TOPIC: RECOMMENDATION TO AWARD FOREST LAKE SENIOR

HIGH SCHOOL ARCHITECTURAL / MECHANICAL / ELECTRICAL CONSTRUCTION BID PACKAGE NO. 3

BACKGROUND: DLR Architects, in conjunction with ICS Consulting have developed phasing for all of the projects at Forest Lake Senior High School.

PROCESS: DLR Architects and ICS Consulting created the bid specifications. The project was advertised for bid on November 3 & 10, 2016. The bid opening took place on November 29, 2016 at the District Office. The bid tabulation and a recommendation were processed after the bid opening by ICS Consulting.
