Career Education

The Law--OAR 581-022-0405: Each school district shall implement plans for career education Grades K through 12, as part of its comprehensive guidance and counseling program.

District Compliance:

Policy IJ – Guidance Program

K – 8 students receive career education through their regular education curriculum, including Career Focus opportunities. Students in grades 7-12 participate in the development of their Education Plan and Education Profile through Tech in the Workplace and Senior Focus.

Prevention Education Programs in Drugs and Alcohol

The Law--OAR 581-022-0413: Each school district shall develop a comprehensive plan for a drug and alcohol prevention program

District Compliance:

Policies JFCK – Elimination of Drugs and Alcohol on School Premises & JFCH – Alcohol, IGAEB – Drug and Alcohol Prevention, Health Education Student Assistance Book

Participation in "Coordinated School Health Program"

Alcohol and Drug abuse prevention education is provided to staff through workshops and curriculum development

Anabolic Steroids and Performance Enhancing Substances

The Law--OAR 581-022-0416: Each school district shall utilize evidence-based programs for the reduction in anabolic steroid and performance-enhancing substance abuse by high school athletes.

District Compliance:

Policy IGAEC - Anabolic Steroids and Performance-Enhancing Substances

Training is required for all coaches through OSAA

Safety of School Sports - Concussions

The Law--OAR 581-022-0421: Each district shall utilize evidence-based programs for the reduction of concussions by high school athletes.

Training is required for all coaches through OSAA

District Improvement Plan

The Law--OAR 581-022-0606: Each district shall conduct self-evaluations in order to develop and/or update their local district continuous improvement plans on a biennial basis.

District Compliance:

CIP goals are reviewed and revised at the Board level based on data and survey information from staff, students and community stakeholders. CIP is now available online through ODE eCIP process. An annual report is made to the community in the Fall.

Administration of State Assessments

The Law--OAR 581-022-0610: The school district shall administer achievement tests provided by the Oregon Department of Education at specific grade levels.

District Compliance:

Policy IL - Assessment Program

Test coordinator, Test administrators and staff are trained by ODE training tools and utilize the Test Administration Manual, as needed. All staff must complete training and sign an Assurance of Test Security Form each school year.

Students are assessed through the OAKS Online system at the benchmark levels. Student assessment data is utilized to differentiate instruction to meet student needs to meet benchmark standards. The ELPA assessment is administered to all students determined to be eligible for English language development. Students with disabilities are provided accommodations as allowed through OAKS assessment system. Parents are informed of student assessment data through fourth quarter reporting.

Exception of Students with Disabilities from State Assessment Testing

The Law--OAR 581-022-0612: For the purposes of this rule a "student with a disability" is a student identified under the Individuals with Disabilities Education Act, consistent with OAR 581-015-0051, or a student with a disability under Section 504 of the Rehabilitation Act of 1973.

Parent requests for student exemption from State Assessment testing are placed in the student file.

Assessment of Essential Skills

The Law--OAR 581-022-0615: School districts and public charter schools that offer grades 3 through 8 or high school shall administer local performance assessments for students in grades 3 through 8 and at least once in high school.

Assessment options are available for students to meet proficiency in the Essential Skills. Students have the option of course portfolios, content assessment and work samples.

Essential Skills Assessment for English Language Learners

The Law--OAR 581-022-0617: School districts and public charter schools that offer grades 3 through 8 or high school shall administer local performance assessments for students in grades 3 through 8 and at least once in high school in the student's language of origin for the purposes of accurately scoring the student's work in the student's language of origin..

District Compliance:

Policy IL - Assessment Program

Assessment options are available for students to meet proficiency in the Essential Skills. Students have the option of course portfolios, content assessment and work samples.

Health Services

The Law--OAR 581-022-0705: School districts which employ nurses to provide health services shall employ persons currently licensed to practice as Registered Nurses or Nurse Practitioners in Oregon.

District Compliance:

Policies JHC – Student Health Services and Requirements; JHCC – Communicable Disease, JHCCA, JHCC/GBEB AR – Communicable Disease, GBEB – Staff Illness/Communicable Disease

Health rooms are provided and equipped to provide care, health screening area and an excluded area for communicable diseases.

Our nurse is contracted through our local WESD. First Aid training is determined by district policy and monitored by district and administrative staff.

Policies on Reporting Child Abuse

The Law--OAR 581-022-0711: Each school board shall adopt policies applicable to all school district employees....

District Compliance:

Policies JHFE – Reporting of Suspected Child Abuse and JHFE AR – Reporting of Suspected Child Abuse Staff is trained each fall on district policy regarding Child Abuse reporting. Reports are processed and provided to appropriate agencies and district staff.

Standardization

Substantive Appeals

The Law--OAR 581-022-1065: The Superintendent of Public Instruction will appoint a committee of at least eight members of the educational community to serve annually to review district requests for substantive appeals of school Adequate Yearly Progress (AYP) determinations.

All student data is provided in a secure format utilizing the (SSID) Oregon's Secure Student Identifier and a designation of each subgroup required for reports of Adequate Yearly Progress (AYP).

Diploma Requirements

The Law—OAR 581-022-1130: Each district school board and public charter school with jurisdiction over high school programs shall award diplomas to all students who fulfill all state requirements.

District Compliance:

Policy IKF- Graduation Requirements

Program hours are determined based on district calendar days and daily schedules by grade level. Course syllabi for each subject area are available at each building and updated annually.

Credit Options

The Law--OAR 581-022-1131: A school district or public charter school shall grant required and elective credit towards the diploma or modified diploma.

District Compliance:

Students are provided credit options through their education plan and profile.

Extended Diploma

The Law--OAR 581-022-1133: A school district or public charter school shall award an extended diploma to a student who satisfies the requirements of this rule.

District Compliance:

Extended diploma options are available through an application process. Students must meet eligibility requirements established by the district including, but not limited to significant learning barrier, medical condition and have access to academic resources.

Modified Diploma

The Law--OAR 581-022-1134: A school district or public charter school with jurisdiction over high school programs shall award a modified diploma only to students who have demonstrated the inability to meet the full set of academic content standards for a high school diploma...

District Compliance:

Policies IKF – Graduation Requirements and IKF AR – Modified Diploma Requirements

Modified diplomas are available to students who have demonstrated the inability to meet the full set of academic content standards for a high school diploma even with reasonable modifications and accommodations but who fulfill all state requirements as described in OAR 581-022-1134 and district policies.

Alternative Certificate

The Law--OAR 581-022-1135: A school district or public charter school shall award an alternative certificate to a student who does not satisfy the requirements for a high school diploma, modified diploma, or an extended diploma.

District Compliance:

Alternative certificate is an option for students who do not satisfy the requirements for a high school diploma, a modified diploma or an extended diploma.

Equal Educational Opportunities

The Law--OAR 581-022-1140: Each district school board shall adopt written policies, and the school district shall implement in each school, programs which assure equity, opportunity and access for all students as provided in OAR 581-021-0045 and OAR 581-021-0046.

District Compliance:

Policies JB – Equal Educational Opportunity & JB AR – Equal Educational Opportunity Plan (Students) Equity assurances and the policies regarding harassment, intimidation or bullying and prohibiting cyber bullying have been updated and Board adopted. They are outlined in student handbooks and are available online or upon request.

District Curriculum

The Law--OAR 581-022-1210: Each school district shall provide a planned K-12 instructional program.

District K-12 curriculum include common curriculum goals and academic content standards. Power standards for reading and mathematics are available online.

Literacy Instruction

The Law--OAR 581-022-1215: School districts and public charter schools shall provide age appropriate and developmentally appropriate literacy instruction to all students until graduation.

Identification of Academically Talented and Intellectually Gifted Students

Students are identified for the TAG program through assessment data both behavioral, learning and performance based. The TAG team utilizes intellectual measures in the 97th percentile.

Rights of Parents of Talented and Gifted Students

The Law--OAR 581-022-1320: In carrying out the requirements of OAR 581-022-1310 and OAR 581-022-1330

District Compliance:

Parents are notified at the time of identification and have an opportunity to participate in the planning process.

Programs and Services for Talented and Gifted Students

The Law--OAR 581-022-1330: Each school district shall have a written plan for programs and services beyond those normally provided by the regular school program in order to realize the contribution of talented and gifted children to self and society.

The Law--OAR 581-022-1360: Prior to February 1 of each year, each school district must notify all high school students and the students' parents or guardians of the Expanded Options Program.

District Compliance:

Policy IGBHE – Expanded Options Program

Annual notice to students and parents is provided regarding the Expanded Options Program, including eligibility requirements, purpose, financial arrangements, effects and consequences of not maintaining satisfactory academic progress.

Expanded Options Program Annual Credit Hour Cap

The Law--OAR 581-022-1361: The number of quarter credit hours that may be awarded by a high school under the Expanded Options Program is limited to an amount equal to the number of students in grades 9 through 12 enrolled in the high school multiplied by a factor of 0.33.

District Compliance:

The CAP for Sheridan High School is 85 quarter credit hours. The CAP for Opportunity House is 11 quarter hours. Priority is given to students who are "at risk".

Expanded Options - Purpose

Expanded Options – Alternative Programs

The Law--OAR 581-022-1370: Notwithstanding ORS Chapter 340, any program, agreement or plan in effect on January 1, 2006, that provides access for public high school students to a post-secondary course is not affected by this chapter and may be continued or renewed at the discretion of the parties to the program, agreement or plan.

Pupil transportation is a contracted service. Breakfast and lunch is provided daily. K-8 students attending the After-School program are provided supper. High school students attending the After-School program are provided with a snack. Pupil Transportation and Child Nutrition are monitored through the Department of Education. It is important to check the appearance of buildings and grounds.

Operating Policies and Procedures

All interscholastic activities offered have been approved by the State Board of Education.

Personnel

The Law--OAR 581-022-1710: Teachers, specialists, and administrators employed by the school district must hold valid Oregon licenses and be assigned in accordance with the individual license, district policies, program goals and applicable statutes and administrative rules.

All licensed staff have appropriate Oregon licenses and are assigned appropriately.

District Compliance: (a) core administrator standards to evaluate administrator effectiveness; (b) Visionary Leadership; (c) Instructional Improvement; (d) Effective Management; (e) Inclusive Practice; (f) Ethical Leadership; and (g) socio-Political Context.

Fingerprinting of Subject Individuals in Positions Not Requiring Licensure as Teachers, Administrators, Personnel Specialists, School Nurses

The Law--OAR 581-022-1730: All public school districts shall comply with the requirements for Fingerprinting of subject individuals as defined in and in compliance with OAR 581-021-0500.

District Compliance:

Policies GCDA/GDDA, GCDA/GDDA AR – Criminal Records Checks/Fingerprinting All staff are fingerprinted according to district policy.

Exemptions

The Law--OAR 581-022-1910: The school district may excuse students from a state required program or learning activity, where necessary, to accommodate students' disabilities or religious beliefs.

Waivers

The Law – OAR 581-022-1920: School districts may request two types of waivers: 1) waiver of a specific standard and 2) Educational Flexibility Partnership Demonstration Act (Ed-Flex) Waiver

Appeals Procedure

The Law--OAR 581-022-1940: A complainant may direct an appeal of a final decision by a school district to the State Superintendent of Public Instruction.

Complaint Procedures

The Law--OAR 581-022-1941: Each school district must establish a process for the prompt resolution of a complaint by a person who resides in the district or by a parent or guardian of a student who attends school in the school district.
