

## Advisory School Council (ASC) Meeting Minutes Special Meeting Monday, May 12, 2025

- I. **Call to order** at 3:52 p.m. by Cari Jones, President.
- II. **Members Present**: Cari Jones, Cassandra Christopherson, Tia Christopherson, Robbin Perkins, Sharlet Collins, Jay Mihal (online), Sadie Barajas, Shelly LaGrou and Debbie Fehr
- III. **Approval of the Minutes from 5/5/25 meeting:** Sharlet moved approval of the agenda and Shelly seconded, motion carried.
- IV. **Treasurer's Report:** as of 4/4/25 \$24,135.94, as of 5/2/25 \$27,878.78, Robin motion to accept, Jay seconded, motion carried.
- V. **Coaches Report:** Sharlet, Taekwondo District Meet, \$450 combined cost for kids, Rooms \$714, Rental Car \$425 each car for5-days, 5 passengers each car, Ernie and Kadyn, Sharlet and Landon going
  - Air fares approx.: \$1943 and Ferry rides approx. \$292.50, food for 5 days x's 4=\$1200, all expenses motion by Debbie for District Meet not to exceed: \$5,000, second by Shelly, motion carried.
