

- Academic freedom;
- Course load and schedules;
- Honors; and
- Athletics programs.

- SB 1047 clarifies that a person who qualifies for an exemption on property taxes of a donated residence as a disabled individual, an individual over the age of 65, a disabled veteran, or a veteran's unmarried surviving spouse may make four equal installment payments.
- HB 150 implements a constitutional amendment that grants a partial property tax exemption to partially disabled veterans when a residence has been donated to the veteran and reduces the interest rate on the resident's homestead for a taxpayer who is 65 or older or disabled during the tax collection deferral or abatement period.
- SB 15 provides an exemption from taxation of the total appraised value of the home for a surviving spouse of a first responder killed in the line of duty.
