

Professional Development opportunities are selected to address student achievement deficiencies, innovative instructional design, improving teacher quality and compliance. In addition, teachers participate in a Needs Assessment and principals conference with teachers as part of the evaluation process.

Professional Development at SD 150 is funded from two sources. The district received \$19,961 from federal Title II Improving Teacher Quality funding. From these funds, the District pays for administration of the funds, professional development credits, district-wide needs, and individual mini-grants. The mini-grants are a long standing means of Professional Development the District uses to focus on pockets of necessary, flexible, and diverse Professional Development needs. In addition, the District receives approximately \$30,000.00 from a newly (2014-2015) created SDE budget item. From these funds, each building was designated \$10,000.00 to be used at the building level for professional development designed to address professional development need customized to each level.

The district participates in SafeSchools which is an online safety program provided by the insurance company. SafeSchools provides online training modules on a variety of topics ranging from social issues and boundaries, to fall prevention and chemical storage. The fee is minimal. Training can be provided for the entire staff, for remediation efforts, or by staff category. Fall 2015, the District implemented SafeSchools Policy component where staff will be assigned pertinent district policy for review. The program keeps track of compliance.
