Authority for this Action	Board Policy CH (Local): <ul style="list-style-type: none">The Board delegates to the Superintendent or designee the authority to make budgeted purchases for goods or services. However, any single, budgeted purchase of goods or services that costs \$50,000 or more, regardless of whether the goods or services are competitively purchased, shall require Board approval before a transaction may take place.
Goal/Objective Addressed	Crosby ISD will be a good steward of taxpayers' money.
Background	<p>IXL is personalized, computer-based learning in mathematics and social studies. IXL provides comprehensive K-12 curriculum, individualized guidance, real-time analytics, and meets the unique needs of each learner. IXL creates a personalized action plan for each student. With these recommended skills, teachers have a simple way to close learning gaps and facilitate meaningful progress. IXL offers personalized skill recommendations based on what each student has been practicing, so they can grow from where they are.</p> <p>Students access IXL math and social studies content via the internet. Students are assigned skills by teachers. Utilization of the system's diagnostic data helps the teacher determine the correct path for students when acquiring skills. On average, students should spend about 15 – 20 minutes each day on IXL to reach proficiency in one skill.</p>

	<p>Students are permitted to access the IXL platform while at school and away from school.</p> <p>IXL serves as a supplemental resource for students and teachers and supports skill practice and mastery as evidenced by student progress and growth reports.</p>
