II. The corporate and special purpose property taxes extended or abated for 2021 were \$9,936,542.83.

The proposed corporate and special purpose property taxes to be levied for 2022 are \$10,681,587. This represents a 7.5% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2021 were \$690,050.57.

The estimated property taxes to be levied for debt service and public building commission leases for 2022 are \$726,235. This represents a 5.24% increase over the previous year.

IV. The total property taxes extended or abated for 2021 were \$10,626,593.40.

The estimated total property taxes to be levied for 2022 are \$11,407,822. This represents a 7.35% increase over the previous year.
