**BEING** 0.4021 acre tract of land situated in the Jasper C. Baker Survey, Abstract No. 47, City of Denton, Denton County, Texas, said 0.4021 acre tract of land being a portion of those same tracts of land conveyed to **DENTON** INDEPENDENT SCHOOL DISTRICT (DISD) by deeds recorded in Instrument Nos. 2015-119668 and 2015-125302, Official Public Records, Denton County, Texas (O.P.R.D.C.T.), said 0.4021 acre tract of land being a variable width Permanent Water and Electric Easement and being more particularly described by metes and bounds as follows:

**BEGINNING** at a Texas Department of Transportation (TxDot) aluminum disk monument found at the west property corner of the said DISD tract (2015-119668), same being the northwest property corner of that certain tract of land conveyed to the State of Texas by deed recorded in Instrument No. 2010-22537, O.P.R.D.C.T.;

**THENCE** North 88° 54' 06" East, along the north property line of the said DISD tract (2015-119668), at a distance of 10.49 feet passing a TxDot aluminum disk monument found at the southeast lot corner of Lot 1, Block A, Teasley Lane High School Addition, an Addition to the City of Denton, Denton County, Texas, according to the plat thereof recorded in Cabinet V, Slide 355, Plat Records, Denton County, Texas, continuing along the said property line and the south lot line of said Lot 1, in all a total distance of 24.73 feet to a point from which a 1/2-inch iron rod with cap stamped "Coleman RPLS 4001" found at the northeast property corner of the said DISD tract (2015-125302) bears North 88° 54' 06" East, a distance of 669.83 feet, said point also being the beginning of a non-tangent curve to the left having a radius of 1,066.27 feet;

**THENCE** departing the said property line and the said lot line, over and across the said DISD tracts, the following courses and distances:

In a southeasterly direction along the said curve to the left, an arc length of 806.37 feet, and across a chord which bears South 59° 09' 40" East, a chord length of 787.29 feet;

North 07° 33' 26" East, a distance of 12.00 feet;

South 81° 37' 38" East, a distance of 30.00 feet to the east property line of the said DISD tract (2015-125302), same being the west property line of that certain tract of land conveyed to Hillcrest North Properties, LLC by deed recorded in Instrument No. 2015-46908, O.P.R.D.C.T.;

**THENCE** South 05° 14' 40" East, along the said property lines, a distance of 32.76 feet to a 1/2-inch iron rod with cap stamped "Coleman RPLS 4001" found at the southeast property corner of the said DISD tract (2015-125302), same being the southwest property corner of the said Hillcrest tract, said iron rod being on the north property line of that certain tract of land conveyed to the State of Texas by deed recorded in Instrument No. 2010-33823, O.P.R.D.C.T., said iron rod also being on the beginning of a non-tangent curve to the right having a radius of 1,085.92 feet;

**THENCE** along the west property lines of the said DISD tracts, along the east property lines of the said State of Texas tracts and in a northwesterly direction along the said curve to the right, an arc length of 874.00 feet and across a chord which bears North 59° 46' 27" West, a chord length of 850.60 feet to the POINT OF BEGINNING.

The hereinabove described tract of land contains a computed area of **0.4021 acres** (**17,514 square feet**) of land, more or less.
