MEMORANDUM IO: Brackett Independent School District

SUBJECT: Adjunct Faculty Status for Kinney County Extension Agent

The State Board of Education passed an amendment to 19 TAC 129 21 (k)(1). Requirements for Student Attendance Accounting for State Funding Purposes allows public school students to be considered "in attendance" when participating in off-campus activities with an adjunct staff member of the school district. Section 3 of the Student Attendance Handbook states:

(4-12) 1. The student is participating in an activity which is approved by the local board and is under the direction of a professional staff member of the school district or an adjunct staff member. This adjunct staff member must have a minimum of a bachelor's degree and be eligible for participation in the Teacher Retirement System of Texas.

(4-13) Students participating in any activity which is not approved by the local school board and /or without certified district personnel supervision are counted absent [see 94-12]. To qualify for funding purposes, the certified district staff member/adjunct staff member must be accompanying the students as an official of the school district for the specific purpose of supervising the students and must be approved by te school board to supervise the activity. For example, students participating in 4-H activities which are supervised solely by a County Extension Agent are reported present.

This amendment provides local school boards the opportunity to recognize county Extension agents as adjunct staff members and to count students participating in 4-H/Extension educational activities "in attendance for Foundation School Program purposes."

Kinney County requests adjunct staff member status for the county Extension agent for the school year 2007-2008. The following faculty are eligible for participation in the teacher Retirement System of Texas and have a minimum of a bachelor's degree.

- 3. Adjunct faculty member is and shall remain an employee, in good standing, of the Texas Cooperative Extension.
- 4. Adjunct faculty member shall be under the direct supervision of either the District Extension Administrator of District <u>10</u>, TCE District, or <u>Kinney</u> County Extension Director.
- 5. Adjunct faculty member shall receive all group insurance benefits, workman's compensation insurance benefits, unemployment insurance, and any and all other plans for the benefit of Texas Cooperative Extension employees. District shall have no responsibility for any of such benefits or plans.

Adjunct faculty member shall direct the activities and participation of students of the District in sponsored and approved activities as designated from time to time by adjunct faculty member for which notice shall be give to District administrative personnel. Adjunct faculty member's activities and participation with students of the District are directed, supervised, and controlled by and through supervisory personnel of Texas Cooperative Extension pursuant to the supervisory authority of the District Extension Administrator or County Extension Director. The adjunct faculty member shall comply with all Board and District directive, state and federal laws and rules, District policy, and regulations as they exist or may hereafter be amended.

This appointment is made by $\underline{Brackett}$ Independent School District by and through the Board of Trustees of said District for the benefit of allowing voluntary student participation in programs conducted by Iexas Cooperative Extension in recognition of the educational benefits arising from such participation and activities and/or directed by Iexas Cooperative Extension. This appointment is made in accordance with the provisions of Section 129.21(k)(1) of the Iexas Administrative Code authorizing the school to deem such participating students in attendance for foundation school program purposes
