Public Hearing on School First Rating

Discussion and Cathi Robbins, Grant Coordinator provided the Board of Trustees a summary Review 2011-2012 Head Start Budget of the Ann Windle School for Young Children (AWSYC) Head Start Administrative Requirements and Standards from section 644 of the Head Start Act. Annually each Head Start Agency reports the following information from the most recently concluded fiscal year:

- The total amount of public and private funds received and the amount from each source.
- An explanation of budgetary expenditures and proposed budget for the fiscal year.
- The results of the most recent review of the financial audit.

AWSYC is funded by a Federal Grant in the amount of \$1,274,420.00. The grant requires a local match of 20% or \$318,650.00 with an actual match of 23.8%. A total from all sources during the 2011-12 school year for matching dollars is \$735,857.00. As a result of AWSYC designation as a Head Start Program, Denton ISD is able to serve 193 students in a full day program implemented by 12 highly qualified/degreed teachers.

Impact of Funding Cuts

Dr. Jamie Wilson, Superintendent updated the Board on the Impact of educational funding cuts. The cuts included \$11 million for 2011-12 school year and about 8 percent or \$15.2 million for the 2012-13 school year. This included cutting district level personnel in all areas: curriculum, technology and athletics with all divisions reducing personnel. It also included reducing field trips and eliminating certain software titles and increase class sizes.
