

RESOLUTION APPROVING 2025 TAX LEVY

WHEREAS, the Board of Education of Riverside School District No. 96, Cook County, Illinois, has determined the amount of money that is necessary to be raised by taxation for the year 2025; and

WHEREAS, the Board of Education has heretofore adopted a Budget Resolution for the District for the fiscal year commencing July 1, 2025 and ending June 30, 2026; and

WHEREAS, the Board of Education has complied with the Truth in Taxation Law (35 ILCS 200/18-55, et seq.); and

WHEREAS, the Board of Education complied with the requirements of the Open Meetings Act (5 ILCS 120/1, et seq.) requirements regarding the adoption of its levy.

WHEREAS, the Board of Education disclosed at a public meeting its intention to adopt a levy; and

WHEREAS, the Board of Education provided notice of its intent to adopt a levy.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Board of Education of Riverside School District No. 96, Cook County, Illinois, as follows:

1. That there shall be and there is hereby levied by the Board the amounts set forth on Exhibit A attached hereto and made a part of this Resolution, which is the Certificate of Tax Levy for the year 2025.

2. That the Board President and Board Secretary are hereby authorized to execute the Certificate of Tax Levy and supporting forms and Certifications and the District Administration is hereby authorized and directed to file the Certificate of Tax Levy and all supporting forms and Certifications with the County Clerk of Cook County, Illinois.
