TES cabinets are collapsing on themselves. Will replace these over the next few years. At DES we did some windows a couple years ago. Will take care of the district office and downstairs. There is a fairly large amount under asphalt and land improvement. Parking lots in general are not good.

WHEREAS, said written notice of the proposed placement on unrequested leave contained a statement setting forth the reasons for the proposed placement as well as a statement that she was entitled to a hearing before the school board provided she make a request in writing within fourteen days of receipt of said notice, and that if no hearing was requested within said fourteen day period it constituted acquiescence by Michelle Norman to the school board's proposed action, and,

WHEREAS, no written request of any kind was received by the school board or superintendent of schools from Michelle Norman for a hearing as of April 6, 2010, and,

WHEREAS, said failure to make written request for a hearing within fourteen days after receipt of notice of proposed placement on unrequested leave constitutes acquiescence by Michelle Norman to her placement on unrequested leave.

BE IT HEREBY RESOLVED, by the School Board of Independent School District No. 877 that Michelle Norman be and hereby is placed on unrequested leave of absence as a teacher of Independent School District No. 877 on the grounds of financial limitations and discontinuance of position effective at the end of the 2009-10 school year on June 30, 2010, pursuant to Minnesota Statutes, Sec. 122A.40, Subd. 10, without pay or fringe benefits.

BE IT FURTHER RESOLVED, that said placement on unrequested leave of absence is not a result of the implementation of an education district agreement.

BE IT FURTHER RESOLVED, that a notice of placement on requested leave of absence, together with a copy of this resolution be forwarded to said teacher personally and that an affidavit of same be placed in her file together with a copy of the notice and resolution.

### 6. REPORTS

a. Revised Policy #630 – Early Entrance, Pam Miller
First reading to early entrance admission policy. No changes to procedures, but
cleaning up the policy. One additional strike-through: page 1 in part 3B, early
entrance admission assessment. There is a new strikethrough after "visit to
kindergarten.

Discussion: Do the screeners recommend students for early entrance or is it really the parents who say they want their child screened? We have three trained screeners: Nancy at HES, Lynn at MES, Denise at PES who are trained on the Gazelle Development Assessment. They go through 3-day training on child's readiness. Typically we get 1-4 or 5 in a year at each of the three communities. Do we track how they acclimate? No. We had some conversation last week that parents signoff on a 12-week trial period, so if the child is eligible for early entrance, we had an informal conversation about how those kids fare and the consensus was they do well. We are only looking at September/October birthdays. This will be presented at the May Meeting for approval.

## 7. DISTRICT COMMITTEE REPORTS

PPokorney: NWSISD – New federal guidelines for racial isolation. Used to be 50:1 students of color then you were considered racially isolated. Now 50.1 of multiple color is not considered racially isolated. NWSISD is a lean machine now and there are other districts that would like to participate. The vision may be to allow NWSISD to facilitate two districts to work together. Maybe Rockford and Buffalo would do some things together and NWSISD would facilitate us working in smaller groups rather than one large group. Will look at Website for NWSISD, because we are part of the consortium, There is a translation device on our website, like Google, that would allow a parent to click and translate to their language.

DWilson: Rotary: As a result of the recent car accidents in other communities, they are talking about beginning to work with the school and maybe Student Council. It would include donation of funds to do a project to get the message out. There were 7 in those accidents without seat belt usage. We do a pretty good job at Buffalo, but it was the suggestion that it go through Safe Communities working with the schools. Ashley Michalko – that is a good idea. Dave - if it comes from student council, it might mean more. Delano and Dassel have the crash reenactment

and students in drama play important parts. Helicopter comes. Parents who have lost teens often talk. Do we do anything like that in our high school? Not at this time. Not the reenactment. We do have a crash vehicle.
