The Board of Trustees Boerne Independent School District

A Regular Meeting of the Board of Trustees of Boerne Independent School District was held Monday, May 12, 2025, beginning at 4:30 PM in the BISD Board Room, 235 Johns Road, Boerne, TX 78006.

I. CALL TO ORDER

Garrett Wilson called the meeting to order at approximately 4:30 p.m.

Carlin Friar - Provided a report from the finance committee meeting. The committee discussed stipend proposals, employee raises on midpoint or actual salary, assistant principal

compensation, preliminary 2025 property values, and received a bond budget update. *Dallas Pipes* – Provided an update from the district technology advisory council meeting. The group reviewed the technology plan, evaluated class sets vs. one to one devices, and discussed artificial intelligence.

Kristi Schmidt – Provided a report from the PTO presidents meeting. The PTOs have been working hard to celebrate teachers and staff in honor of teacher appreciation week and their efforts are much appreciated. The board recently hosted a breakfast in appreciation of PTO Officers. The event was a big success and Kristi expressed gratitude to those who helped with the event.

Rich Sena – Provided a legislative update. The legislative session ends on June 2. Mr. Sena provided updates on pending legislation pertaining to public school finance such as HB2, bills on property tax relief, and HB 1481.

Garrett Wilson – Noted that new BEF board members were elected at the last BEF meeting.

B. Superintendent

1. District Updates

Dr. Craft provided the district update. Current enrollment is 11,141. Dr. Craft noted that many end of year events and celebrations are underway. Over 250 students from CHS and BHS earned approximately \$330,000 in scholarships this year and we are thankful for our generous community. An event entitled Raising Resilient Middle Schoolers was held on May 5th. Over eighty families attended to learn tips on how to help elementary students prepare for middle school. Graduating seniors in the Education Pathway will be recognized this week and will be offered a letter of intent to return to BISD to complete their student teaching. Dr. Craft enjoyed attending the Chamber of Commerce Lemonade Day and met many student entrepreneurs and their families. Dr. Craft provided an update on security audits. Twelve of the our 14 campuses have been audited by TEA. There was one finding of an exterior portable door not latching properly and the door has been fixed.
