When bids were received on August 16, 2011, six were received; however, two were from vendors who did not attend the mandatory pre-bid meeting so they cannot be considered. Of the remaining four, two are being verified for accuracy of fee submitted and reference check.

We are not able at this time to make a recommendation but will be prepared to do so at the Board meeting Tuesday evening.
