Thom Hulme made a motion to approve the CHS Varsity bi-annual Cheer Competition trip to Honolulu, Hawaii from March 30, 2017 through April 4, 2017, per Board Policy FMG (LOCAL). Judy Barbo seconded the motion. The motion carried 6-0.

Amy Dungan made a motion to approve changes to Board Policy DC (LOCAL): Employment Practices regarding the employment of contractual personnel, as presented. Thom Hulme

seconded the motion. The motion carried 6-0. (This item was tabled at the June 20, 2016 Special Board meeting.)

Amy Dungan made a motion to approve a salary increase for the Superintendent at the same percentage increase as provided to all other employees of the District. Leigh Walker seconded the motion. The motion carried 6-0.

A motion was made by Tracy Fisher to execute the Superintendent's contract with extension and salary increase. Thom Hulme seconded the motion. The motion carried 6-0.

Amy Dungan made a motion to approve the Bond Oversight Committee Charge, with changes, and timeline as presented. Leigh Walker seconded the motion. The motion carried 6-0.

Anthony Hill nominated Leigh Walker to serve as an official voting delegate to the 2016 TASB Delegate Assembly. The nomination was seconded by Tracy Fisher. The Board voted 6-0 in favor of the nomination.

Tracy Fisher nominated Jill Popelka to serve as alternate delegate to the 2016 TASB Delegate Assembly. Amy Dungan seconded the nomination. The Board voted 6-0 in favor of the nomination.
