#### PREVIOUS DAMAGE PROVISION

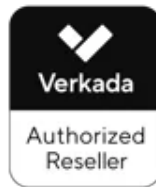
Door frame misalignments, door hinge malfunctions, and other physical door issues cannot and will not be repaired.
