- Sec. 39.0545. SCHOOL DISTRICT EVALUATION OF PERFORMANCE IN COMMUNITY AND STUDENT ENGAGEMENT; COMPLIANCE. (a) Each school district shall evaluate the district's performance and the performance of each campus in the district in community and student engagement and in compliance as provided by this section and assign the district and each campus a performance rating of exemplary, recognized, acceptable, or unacceptable for both overall performance and each individual evaluation factor listed under Subsection (b). Not later than August 8 of each year, the district shall report each performance rating to the agency and make the performance ratings publicly available as provided by commissioner rule.

- Wellness and physical education
- Community and parent involvement
- 21st Workforce development program
- 2nd language acquisition
- Digital language acquisition program
- Dropout prevention strategies
- Educational programs for GT students
- Compliance with statutory reporting and policy requirements

PROCESS

- Each subcommittee solicited participation through networking through their organizations and met with their members to gather community input and update the survey questions based on their subcommittee's recommendations.
- These recommendations were vetted by the full HB 5 Committee and the final survey was sent to campuses to complete with the assistance of their campus improvement teams.
- The Community Engagement Full Committee recommended that the district score be based from the averages of all of our campuses scores.
