**1. Establishment of a Quorum and Call to Order**

H. Frydman called the meeting to order at 6:43 p.m. The roll was called and a quorum was present.

**2. Consent Agenda**

**A. Approval of Minutes – Curriculum Committee Meeting – March 25, 2025**

**3. New Business**

**A. Next Generation Accountability Report**

Lisa Lamenzo, Executive Director of Teaching, Learning, and Leadership shared an overview of the CT Next Generation Accountability System indicators. She gave a brief explanation of the indicators and how the indicators are weighted by school type. The left column of the Next Generation Accountability Report documents the indicators and sub-indicators. Ms. Lamenzo reviewed the available and projected district indicator data. It was noted that Wintonbury Early Childhood Magnet School is not included on this report and the only indicator for Laurel Literacy Academy is Chronic Absenteeism.

T. Mack-Mohammed inquired about the district goal relative to this report. Dr. Youngberg noted our district goal is 74-75%. She further noted that the district celebrated those teachers who outperformed the state and held a collaborative session to see what teaching strategies worked for them.



H. Frydman noted it is encouraging to see growth. He inquired what Bloomfield looks like in comparison to other districts. Dr. Youngberg noted the data is not officially released from the state, but data can be compared to our District Reference Group (DRG).

**B. Roundtable Reflections**

Dr. Tracy Youngberg, Superintendent of Schools, shared an overview of the Roundtable Reflections. This is a meeting of both Operations, Teaching and Learning and the School Principal. The "Operations" includes Food Services, Safety, Transportation, Extension Program, Information Technology, Facilities and Human Resources. Teaching and Learning includes Student Support Services and the Office of Teaching and Learning. They meet approximately once a month to review needs of the schools and how the schools can be supported.

Dr. Youngberg noted some trends are already being documented among the schools with an overview need to address Information Technology (IT) systems such as connectivity and upgrading equipment.

**4. Adjournment**

At 7:16 p.m., a motion was made by T. Mack-Mohammed and seconded by H. Frydman to adjourn.

The motion passed unanimously 2-0-0.
