The Texas Association of School Boards (TASB) has stipulated that all district employees serving on a TASB Affiliate Board must obtain prior approval from the employee's District Board of Trustees. This requirement is in response to the enactment of Texas House Bill (HB) 3372, which became effective on September 1, 2025.

Although my selection to the TASB Energy Cooperative Board was confirmed prior to the effective date of this legislation, the District's Legal Counsel has recommended the formal adoption of the attached Resolution to ensure full compliance with the new statutory mandate.

As detailed in the Resolution, this is a volunteer position without compensation. The Cooperative Board convenes four (4) times per year, with two (2) meetings conducted virtually and two (2) requiring in-person attendance.
