## Administrative Considerations:

- The Quarterly Investment Report is prepared in compliance with the Board approved Investment Policy, the Public Funds Investment Act and Generally Accepted Accounting Principles (GAAP). This report includes investment activity and ending balances by fund for the third quarter (January-March) of fiscal year 2024-2025.
- Total interest earned during the quarter was \$2,090,909.
- The Board appointed Investment Committee consisting of the Superintendent, the Investment Officers (COO and Director of Finance), and the Treasury Services Coordinator meet every six months to review the investment portfolio, investment options, and recommend appropriate legally authorized and adequately secured investments to invest District funds in accordance with the District's written Investment Policy and Generally Accepted Accounting Principles.
- District funds are primarily invested in local government investment pools, certificates of deposit and money market funds.
