WRITTEN DESCRIPTION OF BELMOND-KLEMME DIRECTOR DISTRICTS - EFFECTIVE JULY 1, 2023

Director District 1: All the area within the school district in Avery Township, Hancock County that is north of 110th Street (also known as Highway B 63 E) excluding the area within the 2020 corporate limits of the city of Goodell and excluding a small area of the school district that is north of 110th Street and west of Vail Avenue in Section 27; all of the area within the school district in Twin Lake Township, Hancock County (excluding the city of Goodell); all of the area within the school district in Ell Township, Hancock county including the city of Klemme; all of the area within the school district in Liberty Township, Hancock County.

Director District 2: All of the area with the city of Belmond (2020 corporate limits) bounded by a line beginning at the west corporate limits and US Highway 69 (also known as River Avenue N): thence southerly along US Highway 69 to 3rd Street NE, thence easterly on 3rd Street NE to 8th Avenue NE, thence northerly on 8th Avenue NE to 7th Street NE, thence easterly on 7th Street NE to Taylor Avenue, thence northerly on Taylor Avenue to the north 2020 corporate limits of the city of Belmond, thence westerly and southerly along the corporate limits to the point of beginning; all of the area within Pleasant Township that is west and south of 120th Street and Taylor Avenue.

Director District 3: All the area within the school district in Franklin County; all of the area within the school district in Blaine Township, Wright County; all of the area within the school district in Iowa Township, Wright County including the city of Rowan; all of the area within the school district in Grant Township, Wright County; all of the area within the school district in Pleasant Township, Wright County excluding area within the city of Belmond 2020 corporate limits and excluding Pleasant Township area that is south and west of 120th Street and Taylor Avenue; all of the area within the school district in Belmond Township, Wright County excluding area within the city of Belmond 2020 corporate limits; all of the area within the school district in Norway Township, Wright County; all of the area within the school district in Avery Township, Hancock County that is south of 110th Street (also known as Highway B 63 E) including a small area north of 110th Street that is west of Vail Avenue in Section 27; all of the area within the 2020 corporate limits of the city of Goodell.

Director District 4: All of the area with the city of Belmond (2020 corporate limits) that is south and west of a line beginning at the west corporate limits and US Highway 69 (also known as River Avenue N): thence southerly along US Highway 69 to 3rd Street NE, thence easterly on 3rd Street NE to 4th Avenue NE, thence southerly on 4th Avenue NE to 1st Street NE, thence easterly on 1st Street NE to 5th Avenue NE, thence southerly on 5th Avenue NE to 5th Avenue SE, thence continuing southerly on 5th Avenue SE to 1st Street SE, thence easterly on 1st Street SE to Montclare Lane, thence southwesterly along Montclare Lane to Windsor Place, thence easterly on Windsor Place to Luicks Lane S, thence southerly along Luicks Lane S to Taylor Avenue, thence continuing southerly on Taylor Avenue to the south corporate limits of the city of Belmond.

Director District 5: All of the area with the city of Belmond (2020 corporate limits) that is east of a line beginning at the east corporate limits and Taylor Avenue: thence southerly on Taylor Avenue to 7th Street NE, thence westerly on 7th Street NE to 8th Avenue NE, thence southerly on 8th Avenue NE to 3rd Street NE, thence west on 3rd Street NE to 4th Avenue NE, thence southerly on 4th Avenue NE to 1st Street NE, thence easterly on 1st Street NE to 5th Avenue NE, thence southerly on 5th Avenue NE to 5th Avenue SE, thence continuing southerly on 5th Avenue SE to 1st Street SE, thence easterly on 1st Street SE to

Montclare Lane, thence southwesterly along Montclare Lane to Windsor Place, thence easterly on Windsor Place to Luicks Lane S, thence southerly along Luicks Lane S to Taylor Avenue, thence continuing southerly on Taylor Avenue to the south corporate limits of the city of Belmond.
