A-1 State Board Review of PLSB 20-121 Ethics Hearing Committee Recommendation – Tiffany Gant

Description: Ms. Gant was employed as a teacher under an ACT 1240 waiver. Ms. Gant has appealed her ethics hearing recommendation and requested a State Board review pursuant to 16.02 of the Rules Governing the Code of Ethics for Arkansas Educators. Ms. Gant is represented by attorney Mr. James Valley.

State Board members heard presentations by Mr. Valley and Ms. Douglas. Board members asked clarifying questions of Mr. Valley, Ms. Gant, and Ms. Douglas.

Ms. McFetridge moved, seconded by Mr. Sutton, that Standards 1 and 2 were violated. A roll call vote was taken. The motion passed unanimously. Ms. Chambers moved, seconded by Ms. McFetridge, to accept the PLSB recommended sanction of Level 4 Public Notification of Ethics Violation. A roll call vote was taken. The motion passed with four (4) votes. Dr. Moore and Dr. Hill abstained.

A-2. Critical Academic Licensure Shortage Areas for the 2021-2022 School Year

Presenter: Dr. Frank Servedio

Ms. McFetridge moved, seconded by Ms. Chambers, to accept the Critical Academic Licensure Shortage Areas. The motion passed unanimously.

A-3. Consideration of One-Year Standards for Accreditation Waiver Request - Mountain Pine School District

Presenter: Tracy Webb

Description: The Mountain Pine School District is requesting a waiver of two of the required 178 student-teacher interaction days due to a power outage in the community during the snow storm. The school is planning to add thirty minutes to the end of the school day for twenty-four days to make up the missed instructional time. The waiver is requested for the 2020-2021 school year.

State Board members asked clarifying questions. Ms. Chambers moved, seconded by Ms. Woods, to approve the waiver request. The motion passed unanimously.

A-4. Consideration of District Waiver Request - Gravette School District

Presenter: Tracy Webb

Description: The Gravette School District is requesting a waiver of library media specialist ratio and time requirements in the middle and high schools so that the specialists can provide additional support and remediation to ninth grade students who have failed a course due to unsuccessful virtual learning. The waiver is requested for three (3) years.

State Board members asked clarifying questions. Ms. Chambers moved, seconded by Ms. McFetridge, to approve the Act 1240 waiver. The motion passed unanimously.

A-5. Consideration of District Waiver Extension Request - Barton School District (*Note: Item considered before A-4 in meeting)

Presenter: Tracy Webb

Description: The Barton School District is requesting a waiver extension of class size and teaching load for high school seminar courses, library media specialist ratio for K-12, daily planning period for K-12, school start date and teacher licensure for K-12. The waiver extension is requested for five (5) years.

Ms. Chambers moved, seconded by Ms. Woods, to approve the **Counselor Class Size** waiver for five (5) years with a mid-point report at year 2.5. The motion passed unanimously. Mr. Sutton moved, seconded by Ms. McFetridge, to approve the **Library Media Specialist Ratio** waiver for five (5) years with a mid-point report at year 2.5. The motion passed unanimously.
