### PROGRAM SALES UPDATE -

May numbers are in. Participation fell slightly below budget for both breakfast and lunch participation due to many year end field trips and the annual early departure High School Seniors. Catering continues to struggle as the economy and cuts in spending have been experienced. Snack counts are lower than budget and Supper programs are at above budget as we move these several snack programs to a Supper format. This allows larger reimbursement dollars to the district for each served meal while providing the students a larger, better balanced meal. Our goal would to change all current snack programs to supper programs in the 2009-2010 school year to benefit all parties involved.

## SAFETY UPDATE -

As a continued focus on Safety, we continue to focus on safe practices within the program. As the year winds down, the Food and Nutrition program has had only 2 reported accidents for the year. One was the result of a staff member giving the Heimlich maneuver to a choking student which resulted in a lower back strain. The other was a staff member that tripped over a loose freezer door seal that resulted in a shoulder strain. Both staff members we treated and returned to their assigned duties quickly.



We continue the remainder of this school year driving staff awareness, increased focus and informative training. Food and Nutrition Services continues to provide a safe working environment in all our schools as well as incorporating safe work place practices district wide by keeping SAFETY top of mind!

### SUMMER FOOD PROGRAM -



Learning does not end when school let's out, neither does a child's need for good nutrition. The Summer Food Service Program operated by the Three Rivers School District provides free, nutritious meals and snacks to all children within the Three Rivers and Grants Pass School District areas. This helps children in low-income areas get the nutrition they need to learn, play and grow, throughout the summer months when they are out of school.

### EQUIPMENT GRANTS -

Our application for the Summer Food Service Grant was declined due to lack of funding. Oregon Hunger Relief Task Force allotted \$50,000.00 to the entire state of Oregon and stated that approval went to a few districts that had the potential of shutting down without grant support. (See page four)

Dear Michael,

Thank you for submitting a proposal to fund your Summer Feeding Program. We truly regret that we are not able to fund your request at this time.

This year we were grateful to receive approximately \$50,000 from cooperate and private donors, who stepped forward as part of the Oregon Business Hunger Initiative. Unfortunately, the need- as expressed in more than 60 applications- was four times greater than what we are able to fund. Evident in the compelling stories is that just as families are struggling to make ends meet, organizations that serve them are facing real challenges of their own.

The critical priority was given to requests that would either prevent the elimination of feeding sites, or significantly increasing the number and geographic availability of meals served.

We will continue to do all we can to support and advocate for the Summer Food Service program and those of you who work so hard to make it possible.
