#### **Re:** Resolution Declaring Hazardous Student Transportation Routes

The Texas Education Agency (TEA) allows school districts to obtain supplemental state funding for transporting regular, otherwise ineligible students, who live within two miles of their school but who would be subjected to potentially hazardous conditions if they walked to school. The TEA Handbook on School Transportation Allotments requires the Board to adopt language providing the definition of hazardous traffic conditions applicable to the district and identifying the specific hazardous areas for which such funding is requested. Texas Education Code (TEC) Section 42.155(d) and Coppell ISD Board Policy CNA (Legal) states, "a hazardous traffic condition exists where no walkway is provided and students must walk along or cross a freeway or expressway, an underpass, and overpass or a bridge, an uncontrolled major traffic artery, an industrial or commercial area, or another comparable condition."

Prior to the 2019 Texas State Legislative Session, Coppell ISD did not qualify to apply for this funding. However, with the passage of House Bill 3, we now may submit for the state transportation allotment for our regular routes that are over two miles via a roadway, for special education routes, and for routes under two miles that are designated as hazardous by the Board of Trustees. In order to receive funding from the state for hazardous route transportation services for the 2019-20 school year, the Board must adopt a resolution *prior to the first day of school* approving the criteria used to define hazardous routes and identifying the hazardous routes [Board Policy CNA (Local)]. SUGGESTED MOTION: I move the Board adopt the resolution declaring hazardous student transportation routes as presented.

### RESOLUTION OF THE COPPELL INDEPENDENT SCHOOL DISTRICT BOARD OF TRUSTESS REGARDING HAZARDOUS TRAFFIC CONDITIONS

WHEREAS, Education Code 42.155(d) allows the Board of Trustees of Coppell Independent School District to obtain supplemental state funding for transporting regular, otherwise ineligible students, who live within two miles of their school but who would be subject to hazardous traffic conditions if they walked to school;

WHEREAS, the TEA Handbook on School Transportation Allotments and Board Policy CNA (Local) requires the Board to adopt language providing the definition of hazardous traffic conditions applicable to the District and identifying the specific hazardous areas for which funding is requested;

WHEREAS, the Board acknowledges the Education Code 42.155(d) provisions stating that a hazardous condition exists where no walkway is provided and students must walk along or cross a freeway or expressway, an underpass, an overpass or a bridge, an uncontrolled major traffic artery, an industrial or commercial area, or another comparable condition;

NOW THEREFORE BE IT RESOLVED that the Board of Trustees of Coppell Independent School District has defined hazardous traffic conditions in the same manner as stated in Education Code 42.155(d) and has identified the attached specific hazardous areas for each school in which such conditions exist.
