RESOLUTION 10-81 Approval of Transfers of Appropriation and Appropriations for All Funds for Fiscal Year 2009-10

This resolution requests approval of transfers of appropriation and appropriations for all funds.

Background:

- **Resolution Services Fund** Throughout the year, the District Service Plan is an everchanging document. Upon approval, districts may increase or decrease their participation in certain programs, making it necessary for Multnomah Education Service District (MESD) to adjust costs within those programs. Since the adoption, and subsequent revision, of the 2009-10 Budget, districts have increased their participation overall within the Resolution Services Fund.
- **Contract Services Fund** During the year MESD was awarded amounts from the American Recovery and Reinvestment Act. Some of the funds received by the district are allocated as transit amounts which flow through MESD to Columbia Gorge ESD and Hood River School District. The transfer of appropriation from Resolution Services Contingency to the Contracted Services Fund will cover this transit amount.
- Facilities Acquisition and Improvement Fund A portion of this fund must be reappropriated in order to properly account for MESD's portion of SISNET hardware costs.
- **Operating Fund** During the year the MESD Board of Directors authorized the creation of the Risk Management Reserve Fund. It is the District's intention to transfer an amount of \$145,494 into this fund from the Operating Fund. Therefore, it is necessary to transfer appropriation within the Operating Fund to gain the authority needed to make such a transfer.
