

**THE BOARD OF TRUSTEES OF THE
SCURRY-ROSSER INDEPENDENT SCHOOL DISTRICT**

RESOLUTION TO COMMISSION PEACE OFFICERS

WHEREAS, the Scurry-Rosser Independent School District desires to provide sufficient security and protection of students, staff, and property;

WHEREAS, Section 37.081 of the Texas Education Code authorizes the Board of Trustees of the Scurry-Rosser Independent School District to employ security personnel and commission peace officers;

WHEREAS, the Board of Trustees has determined that it is in the best interest of the Scurry-Rosser Independent School District to create the Scurry-Rosser Independent School District Police Department;

IT IS THEREFORE:

RESOLVED, that the Board of Trustees of the Scurry-Rosser Independent School District hereby creates the Scurry-Rosser Independent School District Police Department;

RESOLVED, that all school district police officers must meet all minimum standards for peace officers established by the Texas Commission on Law Enforcement (TCOLE);

RESOLVED, that all school district police officers shall be licensed by TCOLE;

RESOLVED, that the Chief of Police of the Scurry-Rosser Independent School District shall be accountable to the Superintendent and shall report to the Superintendent;

RESOVLED, that the jurisdiction of the Scurry-Rosser Independent School District peace officers includes all territory in the boundaries of the Scurry-Rosser Independent School District and all property outside the boundaries of the district that is owned, leased, or rented by or otherwise under the control of the district;

RESOLVED, that Scurry-Rosser Independent School District peace officers (1) have the powers, privileges, and immunities of peace officers, (2) may enforce all laws, including municipal ordinances, county ordinances, and state laws; (3) may, in accordance with Chapter 52, Family Code, or Article 45.058, Code of Criminal Procedure, take a child into custody; and (4) may dispose of cases in accordance with Section 52.03 or 52.031, Family Code;

RESOLVED, that the Scurry-Rosser Independent School District peace officer shall perform law enforcement duties for the district as determined by the Board of Trustees, including protecting the safety and welfare of any person in the jurisdiction of the peace officer and protecting the property of the school district;

RESOLVED, that the Board of Trustees authorizes commissioned district peace officers to carry weapons if the officer is trained, certified, and meets the minimum standards for peace

officers established by TCOLE;

RESOLVED, that any peace officer assigned to duty and commissioned by the Scurry-Rosser Independent School District shall take and file the oath required by peace officers and shall execute and file a bond in the sum of \$1,000.00, payable to the Board of Trustees of the Scurry-Rosser Independent School District, with two or more sureties, conditioned that the peace officer will fairly, impartially, and faithfully perform all the duties that may be required of the peace officer by law.

RESOLVED, that it is hereby found, determined and declared that sufficient written notice of the date, time, place and subject of the meeting of the Board of Trustees of the Scurry-Rosser Independent School District at which this Resolution was adopted was posted at a place convenient and readily accessible at all times to the general public for the time required by law preceding this meeting, as required by chapter 551, Texas Government Code, and that this meeting has been open to the public as required by law at all times during which this Resolution and the subject matter thereof has been discussed, considered and formally acted upon. The Board of Trustees further ratifies, approves and confirms such written notice and posting thereof.
