1. Call to order at 7 p.m.

C. Black was absent. Girls softball coach Lindsey Westphal and Activities Director, Megan Chatterton briefed the board on a 2025 extended field trip for Girls Softball. The board will vote on the request at the Aug, board meeting. The trip is over the Easter holiday, Parents support the trip. The trip is over a holiday, however students will only miss 1.5 days of school. Team members can attend any religious services on the holiday if they choose. Hazel H. Reinhardt presented Enrollment Projections and Findings. Key findings included: Delano will move from slow enrollment growth to faster enrollment growth From 2013-14 to 2023-24; Estimated school age population in the district increased by 166 students or 7.0%; Resident K-12 enrollment decreased by 3 students or -0.2%; K-12 enrollment increased by 85 students or 3.7%; Nonresidents make up 17.5% of enrollment in 2023-24; The Delano Schools had a net gain of 159 students to other public options in 2023-24; Market share is 77.5%; Except for the Pandemic year, Delano Public Schools experienced net migration every year; Except for two years, Delano Public Schools experience natural decrease, which puts downward pressure on enrollment. E. Erlanson reviewed changes to the Community Ed staff handbook. Changes were made because of teacher contract changes and legislation regarding part time employees. Full time employees start occurring vacation upcoming hiring. M. Schoen reviewed two read policies: 512 School Sponsored Student Publications; 516 Student Medication and Telehealth; 532 Use of Peace Officers and crisis team to remove students with IEPs, From School Grounds; 535 Service Animals in School; 608 Instructional Services Special Education; and, 614 School District Testing and Planning Procedures.

The district is serving approximately 140 students in summer school, extended school year and speech programs.

Check-ins over the summer are approximately 800 and in the school year there are approximately 1,400 check-ins. CE is now focusing on the customer base, ie, who is using what programs, what's working, what's not. There are approximately 250 school age kids in TKC this summer.
