Goals - Equity








Our goal is keep all elementary schools at 740 students or less Our goal is to rezone families as few times as possible so that families have school continuity

Current Boundaries




DENTON INDEPENDENT SCHOOL DISTRICT

Impacted Neighborhoods





Frequently Asked Questions

- My child is receiving special education services. Do I have to move my child?
- My child is in 4th grade this year and will be a 5th grader next year. Does he or she have to move campuses?
- Will there be transportation to the new school?

- ✓ Special Education students are looked at on a case by case basis.
- ✓ 4th graders who will be 5th grade students in the fall may continue to attend their current school as long as the parent is willing to transport the student. Siblings of the 5th grader may request a transfer for 1 year only.
- ✓ Transportation will only be provided for those students in the designated area.
