Follow Up to Questions from the November 17, 2015, Board of Trustees Meeting re: Sole Source Purchases

Question: What evidence do we have that the purchases from Pasco are sole-source purchases, and, do we check other vendors prices to be sure the College is getting the best deal/value?

Answer: As I mentioned in my verbal response to this question sole source purchases are authorized without an accompanying solicitation process by the Texas Education Code Section 44.031(j) which states:

(j) Without complying with Subsection (a), a school district may purchase an item that is available from only one source, including:
(1) an item for which competition is precluded because of the existence of a patent, copyright, secret process, or monopoly;

- (2) a film, manuscript, or book;
- (3) a utility service, including electricity, gas, or water; and
- (4) a captive replacement part or component for equipment.

In the context of the recommendation for approval of reference #3905, the sole source justification is predicated on subparagraph (j)(4), a captive replacement part or component for equipment. This exemption from bidding is predetermined and approved by the College's Purchasing staff by requiring a "Sole Source Justification Form". In this case, the form was completed by Collin science faculty and approved by Purchasing ("Pasco Sole Source Form" - copy attached). The documented justifications were:

- The equipment and accessories listed as sole source with PASCO Scientific are not available for purchase from our other science suppliers. This equipment is designed and manufactured to work in conjunction with the ScienceWorkshop 750 and 700 Interfaces from PASCO Scientific.
- Our chemistry and physics labs are currently outfitted with the ScienceWorkshop 750 and 700 Interfaces from PASCO Scientific. We must purchase the compatible accessories and probes directly from PASCO Scientific in order to make use of these interfaces.

• Competing products would require us to also purchase the user interface and computer software that would be required for the competing product.

In addition we received a written justification from Roseanne Ciccia, PhD, Spring Creek Campus Lab Supervisor, describing the Pasco equipment used and the costs to replace at in which she says, in part,

"We have been using PASCO interfaces and equipment for more than 14 yrs. We recently purchased new 850 interfaces, as the old interfaces were no longer being supported by PASCO. Many of our old interfaces were broken and unrepairable too. The cost to purchase 8 new interfaces for PHYSICS only was over \$10,000. The cost to replace all of the PASCO equipment used in PHYSICS only would probably run over \$100,000."

The second part of the question dealt with whether or not the College prices products from other vendors. Yes, we do. Attached is a listing of currently awarded contracts for scientific lab equipment and supplies ("Documentation for Competitive Bids for Scientific Lab Equipment Supplies" – copy attached).

Cindy,

I am writing this letter at Joy's request re: PASCO and sole source.

Currently, in five labs, we used PASCO interfaces. Interfaces are an intermediary unit or box that is hooked to the computer and then pieces of equipment are attached to the box. When students perform classroom experiments, using PASCO equipment, they attach other PASCO equipment such as a pH probe, a force sensor, a voltage sensor, or a CO2 probe, to the interface. Using the interface software on the computer and the interface, with the equipment, the student's data/results are analysed and recorded.

Our Chem and Bio labs use the interfaces with pH probes to determine chemical pH, temperature probes and others. Physics entire set of University Physics I & II experiments are based on PASCO equipment and interfaces. Some of the freshman level experiments also use PASCO equipment.

As needed, we order replacement or new pieces from PASCO. ONLY PASCO equipment is compatible with the PASCO interfaces and other PASCO equipment. We can only purchase new and replacement pieces from PASCO for PASCO interfaces. Equipment from other vendors are not compatible with PASCO interfaces.

We have been using PASCO interfaces and equipment for more than 14 yrs. We recently purchased new 850 interfaces, as the old interfaces were no longer being supported by PASCO. Many of our old interfaces were broken and unrepairable too. The cost to purchase 8 new interfaces for PHYSICS only was over \$10,000. The cost to replace all of the PASCO equipment used in PHYSICS only would probably run over \$100,000.

We have not yet replaced the interfaces in Chemistry and Physics. These units are still in good working order, as they are not used as often as the PHYSICS units. At some point, we will need to replace these interfaces, so we can continue using our existing probes, meters, etc.
