EXECUTIVE SESSION

ITEMS OF ACTION

A. NEW BUSINESS

43.25 Consideration of Non-Renewal of Faculty Member Contract for FY 2025-2026

Regent Cotten made a motion that the Lee College Board of Regents adopt the recommendation from the College President and nonrenew the employment of Charles Finnell. He further moved that the Board direct the College President to provide the employee notice of the Board's decision consistent with policy and law. Regent Santana seconded.

The motion passed with no dissenting votes. Regent Moore-Fontenot abstained. Regents Guillory and Warford were absent.

44.25 Consideration of Level IV Faculty Grievance

Regent Hall made a motion that the Lee College Board of Regents adopt the findings from its independent investigator and uphold the findings issued in Amanda Summers' investigation of Dr. Jeffrey Clayton's complaint conducted pursuant to Board Policy DIAB. He further moved that the Board adopt the findings of the independent investigator concerning Dr. Clayton's additional complaint concerning the College President dismissing complaints as untimely and denying all further requested relief. Regent Cotten seconded.

The motion passed with no dissenting votes. Regent Moore-Fontenot abstained. Regents Guillory and Warford were absent.
