AGENDA ITEM: Consider Approval of Purchase of Cafeteria Kitchen Equipment

PRESENTER: Earl Husfeld, Chief Financial Officer

BACKGROUND INFORMATION:

- Per Board Policy CH (Local), any single, budgeted purchase of goods or services that costs \$50,000 or more, regardless of whether the goods or services are competitively purchased, shall require Board approval before a transaction may take place.
- Staff in the Child Nutrition Department and Maintenance Department are recommending the replacement of the steamer and dishwasher in the Stuard Elementary School kitchen and the steamer in the Aledo High School kitchen.
- Due to the age of this equipment, the Maintenance Department is having difficulty locating/buying replacement parts for these equipment items.
- Rather than continuing to spend money repairing these items, the best long-term value for the District is to replace them.
- To ensure the best pricing and value, district staff utilized the TASB BuyBoard Purchasing Cooperative to acquire quotes from approved vendors for these equipment items.
- After review of all quotes received from each vendor, the recommendation is to accept the quotes received from Mission Restaurant Supply in the total amount of \$116,132.00.
- Subject to Board of Trustee approval of this item, this cafeteria kitchen equipment will be installed during the summer.

FISCAL INFORMATION:

The cost of \$116,132.00 will be paid from available funds in Child Nutrition Fund 240.
