**TOPIC: RESOLUTION APPOINTING ELECTION JUDGES FOR THE
SPECIAL ELECTION TO BE HELD ON NOVEMBER 3, 2015**

BACKGROUND: Pursuant to Minn. Stat. 471.59, Forest Lake Area Schools has entered into joint powers agreements with our counties to perform election services on our behalf.

PROCESS: The next step in that process is to appoint election judges. The attached resolution appoints election judges.

RECOMMENDATION: The Administration is requesting approval of the attached resolution.

**RESOLUTION APPOINTING ELECTION JUDGES FOR THE SPECIAL ELECTION
TO BE HELD ON NOVEMBER 3, 2015**

WHEREAS, The Forest Lake Independent School District will be conducting a Special Election on Tuesday, November 3, 2015; and

WHEREAS, pursuant to Minnesota Statutes Section 204B.21, election judges for precincts in a school district election must be appointed by the board of that school district; and

WHEREAS, the persons selected to serve meet all requirements of MN statute and district administrative policy, and have been trained and certified pursuant to law.

NOW THEREFORE, BE IT RESOLVED BY THE SCHOOL BOARD OF THE FOREST LAKE INDEPENDENT SCHOOL DISTRICT, STATE OF MINNESOTA, as follows:

1. The individuals listed on Attachments A and B are hereby appointed to serve as election judges for the Special Election to be held on November 3, 2015.
2. In the event circumstances require judges to be appointed in addition to the persons named in this resolution, the Clerk of Election is authorized to appoint as necessary, provided that the persons appointed meet all requirements of MN statute and district administrative policy.
