CALL TO ORDER

INFORMATION ITEMS:

- A grant waiver was promised by the federal government to offset the flight interruptions
 due to construction. Congress adjourned without granting this waiver, so we are no
 longer expected to receive it. As a result, this will impact the plans for the T-hangar.
- Mr. Welch has not signed the contract yet and the 30-day grace period has passed.
 Administrator Osmer will reach out to Mr. Welch.
- The CRTC expressed concerns over the damage done to the concrete on the runway. This is due to the county's equipment needing additional parts and repairs. Until further notice the county is to only plow the asphalt and CRTC will take care of the concrete.
- A ribbon cutting for the runway is planned for November 25th at Building 490 at 1:30 p.m. Invitations to follow.
- The new blower will be paid for using AIP funds.
- The draft agreement for the flight check tests will cost approximately \$20,000 and will come out of the Airport fund.
- There are several other leases that need attention, and Steve will provide a full list before or at the next meeting for review.
- The CRTC expressed that the AJUA needs to be renegotiated soon. They would like to discuss a plan with the airport. The agreement will not be enshrined in the AJUA, instead it will be a handshake deal.
- There have been staffing issues with Alpena Ground Services and discussion was held to look into the contract to ensure compliance.
- Discussion was made that a maintenance plan is needed going forward for the upkeep of our equipment.
- The quantity and stock of lighting was discussed.
