Agenda Item Title: Discussion and Possible action to approve the purchase of Apple devices for the district's technology initiative.

Description: The district's technology initiative is to purchase 3,800 iPads for the elementary schools. This initiative will standardize the learning platforms for the teachers and students on all Elementary campuses. The goal is to increase student engagement and test scores by providing a single device that has longevity, ease of use, is versatile and approved for state testing. The purchase of these iPads aligns with the district's 1:1 initiative. The total cost of the initiative is \$1,950,705.50 and will be paid out from various federal funds and the general fund.

Historical Data: iPads are currently used within the district and all teachers have access to a teacher iPad. Campus administrators have received training from Apple in March, 2023.

Recommendation: The Administration recommends that the Board approve the purchase of the 3,800 iPads for Elementary Campuses.
