2. Workshop Items:

2.1 BES & SES Start Time Switch

Martina Wanger, Director of Teaching & Learning and Jen Grove, Burnside Principal presented a proposal to flip the start times of Burnside and Sunnyside beginning with the 2023-24 School Year.

2.2 <u>2022-23 School Calendar – Snow Days & Days Deduction</u> The 2022-23 school calendar was originally approved with 171 student days for Grades 1-12 and 170 days for Grades K-HK.

Due to extreme weather this year, we issued Snow Days for the following dates: December 22, 2022 February 23, 2023 February 27, 2023

The total days at the end of the 2022-23 School year are as follows: Grades 1-12 = 168Grades K-HK = 167

2.3 <u>First Reading of Policy 516 Student Medication & Policy 516.5 Overdose Medication</u> In 2022 the Red Wing School Board approved a revision to Policy 516 Student Medication to include guidelines pertaining to the drug Narcan.

In May, 2023, MSBA has completed a model policy and recommends modifying our current policy to update specifics and legal references.

Based on a recommendation from the Health and Safety Consultant and District Nurse, the policies were presented for a first reading.

2.4 Policy Review

In compliance with Policy 208, the school board shall review policies at least once every three years.

Due to COVID-19, some policies have not been reviewed in the last three years. The board reviewed policies that had a review date of longer than three years. Policies can be found at rwps.org > District > Policies, Handbooks, and Notices.
