## **BACKGROUND:**

As part of TEA Dyslexia Grant program awarded to the Brownsville ISD, a total of 9 BISD teachers are participating in Region10's Certification Program (CERT) to become Educational Diagnosticians. The purpose of this partnership is for Region 10 ESC to purchase 9 certification exam vouchers for candidates in Brownsville ISD at the cost of \$200 per voucher for the Educational Diagnostician Certification Exam. The Region 10 ESC CERTification Program has agreed to purchase exam vouchers and provide the 9 candidates with a certification exam voucher code for the candidates to register for the exam.

# MEMORANDUM OF UNDERSTANDING

## A MEMORANDUM OF UNDERSTANDING in and Between the Agreeing Parties:

## Region 10 Education Service Center CERTification Programs

&

#### Brownsville ISD

#### **Authorization**

This Memorandum of Understanding (MOU) is an agreement under the authority of the Texas Inter-local Cooperation Act, Gov Code § 791.001 et seq. which authorizes school districts, education service centers and other governmental entities to covenant for the purpose of achieving efficiency in the accomplishment of the governmental administrative functions.

#### <u>Purpose</u>

The purpose of this partnership is for Region 10 ESC to purchase certification exam vouchers for candidates in Brownsville ISD.

## Roles and Responsibilities of Region 10 ESC CERTification Programs

Region 10 ESC CERTification Programs agree to:

- 1. Purchase 9 certification exam vouchers at the cost of \$200 per voucher for the 253 Educational Diagnostician Certification Exam.
- 2. Provide the 9 candidates within Brownsville ISD a certification exam voucher code for the candidates to register for the exam.
- 3. Invoice Brownsville ISD \$1800 for the cost of the 9 certification exam vouchers.

# Roles and Responsibilities of Brownsville ISD

# Brownsville ISD agrees to:

1. Pay the \$1800 invoice to Region 10 ESC.

# <u>Term</u>

This Agreement is effective from the date of execution and shall be in effect unless either party gives thirty (30) days written notice of termination.

## **Dissolution & Termination**

This Agreement may be terminated, with or without cause, by either party upon a thirty (30) day written notice. Upon termination, any outstanding payment for services rendered or goods received are due and payable by either party to the other.

#### **Agreement Amendment**

Once executed, any provision of this Agreement may be amended by the written agreement of both parties.
