JOINT RESOLUTION BY UNITED AND LAREDO INDEPENDENT SCHOOL DISTRICTS SUPPORTING THE ECONOMIC DEVELOPMENT OF THE WEBB COUNTY SCHOOL LANDS

WHEREAS, Webb County, a political subdivision of the State of Texas, owns and maintains the Webb County School Lands pursuant to Article VII, Section 6 of the Texas Constitution, and holds the proceeds of said lands alone as a trust for the benefit of the public schools of Webb County, including United Independent School District and Laredo Independent School (collectively, "Districts"); and

WHEREAS, in order to fully benefit the Districts' students, the Districts desire to increase revenue from the Webb County School Lands;

WHEREAS, in order to maximize revenue from the Webb County School Lands, the Districts believe that renewable energy projects, such as wind and solar farms, should be solicited by Webb County;

WHEREAS, Webb County has entered into a hunting/grazing lease for approximately 2,292 acres located on the Cuchillas and Lomas II Pastures of the Webb County School Lands, which is set to expire on or about October 12, 2021 if Webb County terminates the hunting/grazing lease in accordance with Section III of the hunting/grazing lease;

WHEREAS, Webb County has entered into a hunting/grazing lease for approximately 8,829.57 acres located on the Penjamo and Llano Pastures of the Webb County School Lands, which is set to expire on or about June 23, 2024;

WHEREAS, the likelihood of renewable energy projects developing on the Webb County School Lands is minimal with the existence of the hunting/grazing leases on the Cuchillas and Lomas II Pastures and Penjamo and Llano Pastures;

WHEREAS, the hunting/grazing leases on the Webb County School Lands are encumbering the economic development of the Webb County School Lands;

WHEREAS, in order to maximize revenues for the Districts and their students, the hunting/grazing leases should be terminated as soon as possible so that Webb County can begin soliciting renewable energy projects in order to maximize revenues from the Webb County School Lands that will ultimately benefit students from the Districts and constituents of Webb County;

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The findings and recitals in the preamble of this Resolution are hereby found to be true and correct.
- 2. The Districts' Board of Trustees and administration fully support Webb County providing notice to the lessees that the hunting/grazing leases shall be terminated as soon as allowed by the hunting/grazing leases so that the Webb County School Lands can be economically developed.
- 3. The Districts' Board of Trustees and administration fully support Webb County terminating the hunting/grazing lease for the Cuchillas and Lomas II Pastures in accordance with Section III of the hunting/grazing lease, which will end the hunting/grazing lease on October 12, 2021.
- 4. The Districts' Board of Trustees and administration fully support Webb County terminating the hunting/grazing lease for the Penjamo and Llano Pastures at the end of the lease term, which will end the hunting/grazing lease on June 23, 2024.
- 5. The Districts' Board of Trustees and administration fully support Webb County soliciting renewable energy project for the economic development of the Webb County School Lands.
