Description: Administration recommends approval of the procurement and financing of a virtual infrastructure upgrade to replace the District's outdated system and improve reliability and long-term sustainability. The project includes the necessary equipment, software, and support services to maintain daily operations. The total cost of \$268,608.61 will be financed over five years, resulting in predictable annual payments of \$53,721.72 and minimizing budget impact.

Historical Data: The District's existing virtual infrastructure has reached the end of its useful life, increasing operational risk and limiting scalability. This initiative represents a planned refresh to support continued instructional and administrative operations.

Recommendation: Administration recommends approval of the procurement and associated financing agreement for the virtual infrastructure modernization initiative.
