9. AVID Elementary Training Days:

School System will receive three (3) separate days per training cycle, new or existing. The training cycle for teachers that have yet to be trained in the AVID Elementary Methodologies is called "New Teachers Cycle." The training cycle for teachers that have previously received training in the AVID Elementary Methodologies is called "Existing Teachers Cycle." AVID Elementary Training Days Fee is based on the total number of participants in each training cycles.

The base fee for each individual training cycle is calculated in increments of fifty (50) participants per individual training cycle. The base fee for one to fifty (1-50) participants in a single training cycle is \$7,500. With each additional increment of one to fifty (1-50) participants in a training cycle, the price will increase by \$4,500. Training cycles cannot be combined and will be charged as individual training cycles. The School System agrees to the level of participation as indicated in the table below.

The actual number of participants from the School System will be verified on-site by AVID Center staff and School System agrees to designate a representative from the School System or participating schools to validate that number. If no such representative is available or reasonably identifiable, AVID Center staff will exercise discretion on obtaining such validation. If it is verified that the number of participants exceeds the level of participation as agreed to herein, then AVID Center will invoice the School System for the balance between the level of participation as agreed to herein and the actual level of participation. AVID Center will not issue a credit for actual level of participation that does not meet the level of participation as stated herein. Elementary Training Days calendar dates are subject to AVID Center approval and are scheduled in conjunction with Elementary District Site Visitation Days.
