District Attendance Committee Data and Initiatives

The Attendance Committee has gathered significant data on student absences within our district. Currently, 31% of our students are identified as having severe chronic absences. Of particular concern is the 12th grade, which shows the highest percentage of chronic absences at 44%.

Current Statistics

Out of the 1940 students in our district, 615 have missed at least 9 days of school as of today, Day 87 of the school year. This translates to a substantial portion of our student body facing issues with consistent attendance.

Initiatives and Efforts

In response to these alarming numbers, we are collaborating with the superintendent to develop and implement class and school Initiatives to reduce absenteeism. These initiatives are designed to motivate students to attend school more regularly and to engage both students and teachers positively and constructively.

Future Data and Reporting

We are committed to monitoring the situation closely and will continue to gather and analyze attendance data. Our goal is to provide the board with updated statistics and the effectiveness of our initiatives. We are hopeful that these efforts will yield a significant improvement in student attendance across the district.

ENROLLMENT:

As of January 6, 2025, the K-12's current enrollment is 1827, a decrease of 20 students since November's report.

PreK – 12th grade enrollment is 1940, a decrease of 21 students since November's report.
