

S 104: Alternative Salary Structure

See and hear how the Blue Ridge School District eliminated all rigid salary structures and gave their Governing Board more options to allocate funding for salaries. The Alternative Salary Schedule model has been used by several school districts throughout Arizona.

S 204: Creating a Staffing Model for your District

Recent litigation and clarification of the Fair Labor Standards Act (FLSA) may allow districts to change how they classify support staff who also want to do extra duty assignments, such a coaching. In the past, support staff employees were classified as non-exempt under FLSA and were allowed to perform extra duties with submitted timesheets and overtime pay was correctly included. The presenter will discuss litigation, FLSA issues, and implementation of classifying support staff as volunteers.

S 404: Common Audit Issues Reported in Payroll
