5. Questions regarding *CONSENT #2*. The agenda item summary indicates a start date of September 7, 2017 the actual MOU indicates a start date of October 1, 2017, which date is correct?

Both dates are correct. The program started on September 7 and the new contract starts October 1, 2017. The fiscal year for the contract is October 1 through September 30. The program for September is funded through the previous year budget.
