Recommendation:

Administration recommends award of CSP 071-2015 John B Alexander High School Parking Lots, Traffic Loop, and Athletic Facility Improvements to Leyendecker Construction of Texas in the amount of \$4,405,600 (includes \$150,000 in contingency allowance reserved for the District use only as necessary and includes Alternate 1 for \$6,600, Alternate 2 for \$58,000, and Alternate 3 for \$21,000). Administration also recommends approval of the related budget amendment from General Fund in the amount of \$615,000 to cover cost of project.

Rationale:

Staff has complied with all applicable federal, state and local purchasing policies and procedures in obtaining pricing information for the items listed above. Staff is recommending the awards based on being the best value to the district.

The Facilities evaluation committee reviewed all proposals received for CSP No. 071-2015, John B. Alexander High School Parking Lots, Traffic Loop & Athletic Facility Improvements, and recommends approval of the proposal submitted by Leyendecker Construction of Texas, Inc., in the amount of **\$4,405,600.00**, as the best and lowest proposal meeting specifications.

Leyendecker Construction of Texas, Inc. submitted an initial proposal in the amount of **\$4,558,600.00**, but after further negotiations by the Purchasing Dept., Leyendecker Construction of Texas, Inc. reduced their proposal to a best and final amount of **\$4,405,600.00**, a reduction in the amount of **\$153,000.00** from the original proposal amount.

This total recommended amount of \$4,405,600.00 includes award of Base Bid Item 1 and Base Bid Item 2, includes a contingency allowance of \$150,000.00 for the entire project, and also includes award of Alternates No. 1, No. 2 and No. 3 in the amounts of \$6,600.00, \$58,000.00, and \$21,000.00, respectively.

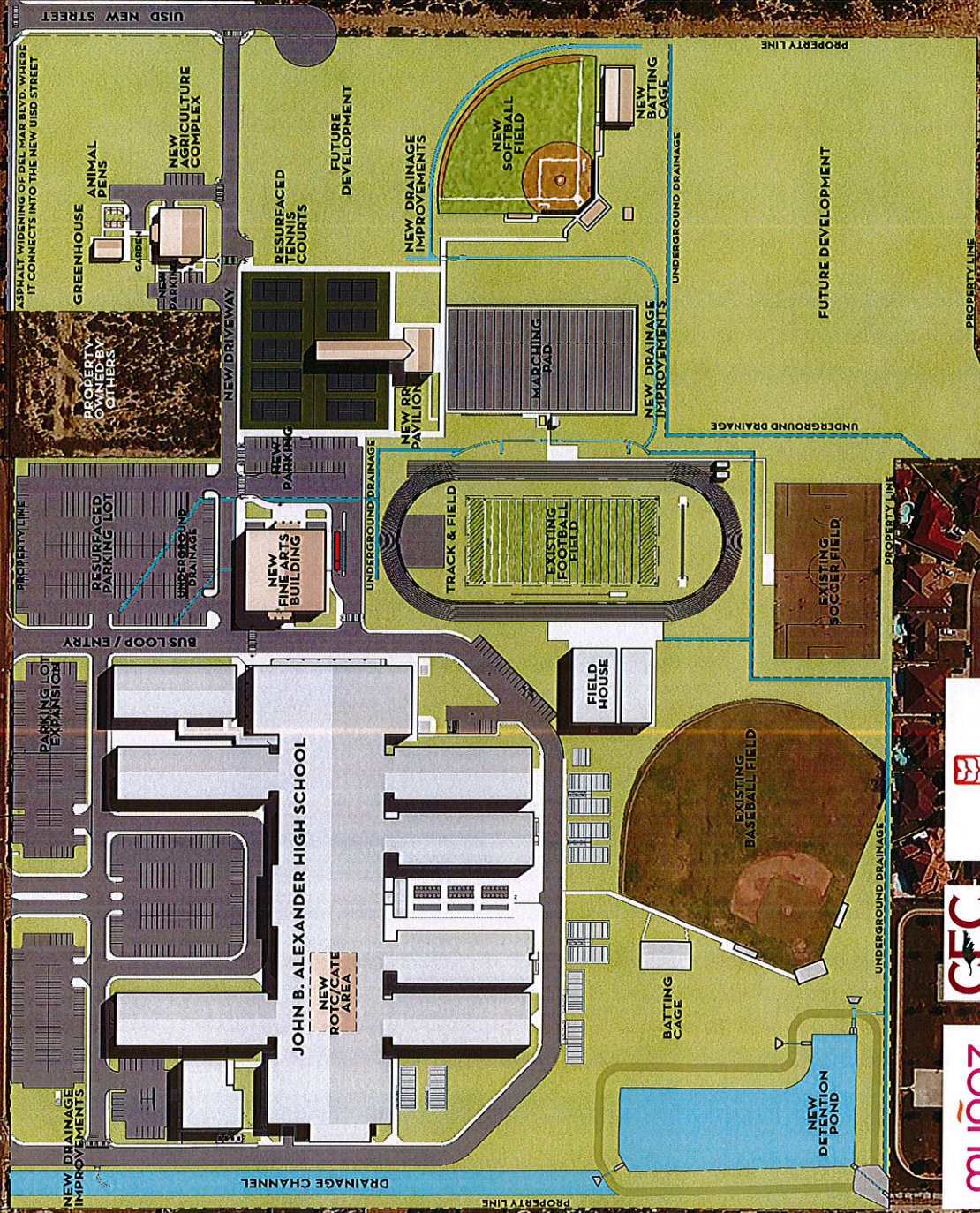
