## 2016-8-2-1 Public Hearing Related to the Proposed 2016 Tax Rate

Chairman Collins asked Acting Vice President of Administrative Services/CFO Ken Lynn to give background information regarding the proposed tax rate. Mr. Lynn said that the public hearing is part of a routine process required by the laws of the State of Texas and specially the truth-in-taxation requirements. The process starts with the Appraisal District and the certification of the value of assessed properties. On August 2, 2016, the Board of Trustees took action to approve the calculated tax rate and rollback rate provided by Ken Maun and reviewed by Mr. Lynn. On August 2, 2016, the Board of Trustees took a recorded vote on consideration of the proposed tax rate for 2016 for Maintenance & Operations Tax Levy of \$0.078174 per \$100 of assessed property value and Debt Service Tax Levy of \$0.003048 per \$100 of assessed property value, for a total of \$0.081222 per \$100 of assessed property value.
