HEALTH SERVICES/SCHOOL HEALTH ADVISORY COUNCIL ANNUAL BOARD REPORT

August 26, 2008

Health is a large word. It embraces not the body only, but the mind and spirit as well;... and not today's pain or pleasure alone, but the whole being and outlook of a man.

Health <u>is</u> a very large word! This board's own goals demonstrate the significance of good health as a basis for excellence in learning and teaching in Denton ISD. This report will provide you with information regarding the district's health services department and the School Health Advisory Council (SHAC) and demonstrate how the activities of that department and committee support the mission of Denton ISD and the board goals.

It is virtually impossible to list every element of care; the information in blue below will, I hope, provide some enlightenment as to how health services contributed to the success of our students in 07-08.

I. Vision ... In pursuit of excellence, the district will:a. develop a culture where learning is our first priority

health services motto is "Healthy kids make better learners." The department as a
whole and each nurse on her individual campus focus efforts on helping each child
be academically successful

II. Teaching & Learning... In pursuit of excellence, the district will:

- b. expect full curriculum implementation on each campus by instructional leaders
- our school nurses do vision and hearing screening and provide referrals and resources to insure that each student has the ability to fully experience classroom instruction; being able to see and hear is paramount to success!
- our overall "health curricular" goals are to help students achieve self-competence
 in health care, make good health decisions daily by weighing consequences, and to
 provide information and skills to help our students develop life-long healthy habits.
 The nurses achieve these goals by doing classroom instruction, through rolemodeling, and by one-on-one health counseling with students and their parents.

- at each grade level, our nurses collaborate with classroom and special areas teachers to provide health education to meet Health TEKS
 To highlight just a few:
 - 1. at AWSYC, Cheryl Reed, who also serves as the Headstart health coordinator, teaches early health habits with puppets, collaborating with the education specialist in "Panda Time." Together they conduct an annual health fair for the parents, providing them with much-needed resources for health care for their families.
 - 2. Kathy Malmberg, our nurse at Hawk Elementary, conducted first aid classes for the kindergartners using the American Red Cross curriculum "First Aid for Little People." She also does CPR and first aid classes for all 5th graders, teaching them basic interventions and empowering them to care for others.
 - 3. At Wilson, Kay Lindsay holds lunch-time group sessions for students with asthma using the "Open Airways" curriculum, helping them learn asthma management techniques and strategies.
 - 4. At Ginnings, Nurse Paulsen did anti-tobacco and drug classes will all grade levels, as well as reading nutrition labels, sun safety, poison prevention, playground and water safety she even went out at recess and walked with the students!
 - 5. At Borman, Nurse Martinez-Andrews taught an innovative pediculosis prevention program, using a Barbie doll head and a salt shaker!
 - 6. At Crownover, Jonita Widmer developed a program specifically for the students in social adjustment classes, geared toward improving their own health and safety
- All elementary nurses teach dental health, growth and development, hand washing, pediculosis prevention, nutrition and personal hygiene to name a few presentations. They collaborate with the school counselors to present the state-required K-5 classes on child anit-victimization, violence and bullying prevention, and they conduct parent meetings each year to discuss our district approach to teaching 4th and 5th graders about pubertal changes.
- Our secondary nurses tackle some of the health concerns of older students infection control, sexually-transmitted diseases, relationship violence, breast and
 testicular self-exams for cancer prevention, and what it means to be an educated
 health consumer in our world today.

High school nurses meet with parents of 9th graders in orientation to alleviate anxieties about high school students taking their own medications at school, about our philosophy and approaches to health education regarding sexual concerns, and about helping our high school students learn about making sound decisions about attendance issues and school success, weighing the consequences of going home that day or staying in class.

Middle school nurses are integrally involved in sports assessments and injuries because we have no athletic trainers at that level. They also help our middle school students develop healthy body images at a time when eating disorders can be a prominent concern.

- c. establish quality staff development programs and promote professional learning communities
- the school nurses meet on staff development days as a group to obtain up-todate information specific to caring for the school age child and the professional practice of school health
- last year was our second year to have "new nurse academy" one a month to
 prepare our newbies (all experienced nurses but new to school health) for the
 practice of nursing in a new environment, and to provide a built-in resource for
 asking questions and learning in a professional environment from seasoned
 school nurses the academy has been well-received and appreciated
- we have sisterhoods that are geographically determined to provide mentorship and back-up for all nurses (attachments A, A1)
- d. strive to deliver all academic programs through teachers possessing advanced degrees and demonstrable competence in their areas of professional responsibility
- entry level for DISD school RNs is a bachelor's degree, two have masters, one a PhD, one just sat for national certification in school health and two more are preparing for that exam
 - e. stay abreast of and incorporate best practices into teaching, learning and leadership
- each school nurse meeting has a time to share best practices in school health, health teaching, and/or management of student health issues

- nine are members of the state (TSNO) and national (NASN) professional organizations for school nurses and receive professional school health journals/other publications
- the director is currently on the board of directors for the Texas School Health
 Association, and is a member of the advisory boards for the Denton County Public
 Health Department and the NCTC School of Nursing. She is also a member of the
 Texas School Nurse Administrators' Association, in addition to NASN and TSNO;
 these memberships help insure that school nursing in Denton ISD is held to a high
 level of professionalism in clinical practice

f.advocate and practice true accountability based on measurement of individual student progress over time, regardless of external mandates

 although some of the services and support that our school nurses provide are state-required, we also help students in many ways that have nothing to do with state mandates. We help students learn to manage their own health issues so that they may be more successful in the classroom and make the most of the instructional time at school - for example, teaching a student to manage their diabetes, asthma, or other chronic health conditions (attachment B) more effectively can mean fewer missed days and an increased ability to pay attention in class.

III. Climate... In pursuit of excellence, the district will

- a. celebrate and respect the diversity in our Denton ISD Community.
- health services collaborates with TWU Center for Lifelong Learning to provide
 "Spanish for School Nurses" classes
- we included in staff development last year time to hear from nurses of various cultures regarding health beliefs and practices from their respective communities
 - b. promote and nourish a safe learning and working environment which is supportive, cooperative, and ensures open communication.
- school nurses participate daily in making the school environment safer and healthier through infection control, health promotion, good nursing assessments that ensure students who might be contagious are sent home in as timely a manner possible. They also contribute to a safer and healthier climate by communicating

frequently with teachers and parents regarding individual student status and with administrators regarding unsafe or unhealthy conditions inside or outside the building

- our nurses provide timely information to their principals regarding weather or other conditions that might adversely affect students during recess or other outside activities
- school nurses track injuries for patterns and trends that may need intervention, and participate in surveillance for communicable disease in conjunction with the county health department and other health practitioners. Last year we had 8 "sentinel" schools whose nurses reported weekly from October through April to the health department, giving them statistical information regarding the numbers of absences due to flu-like illness. They also submitted 29 accident reports that indicated outside play time to be an area of concern for elementary students.
 - e. motivate and prepare students to embrace their full responsibilities as active citizens of their community, nation, and world
- the school RNs develop Individualized Health Plans as a part of the student's
 Individual Education Plan. Involving the students and their parents in health
 planning and interventions at school helps prepare them to assume some of their
 own responsibilities for health care, and sets the stage for them to be
 contributing members of society as their own health advocate and consumers of
 health services

IV. Parent and Community Involvement...In pursuit of excellence, the district will:

- a. foster a positive and welcoming environment that encourages parent and community partnerships to achieve success for all our students
- school nurses made 28,302 documented parent contacts last year to collaborate on health issues
- our nurses made over 9,000 referrals to community resources last year to ensure health care and social services access for the students and their families, to name a few:
 - 1. helped coordinate two Care Van immunization clinics that served 84 students
 - 2. Kiwanis Children's Clinic

- 3. Lion's Club
- 4. HOPE, Inc.
- 5. Interfaith Ministries,
- 6. People's Clinic,
- 7. Denton County Health Department
- coordinated four blood drives at various schools

b. work continuously with the community in planning and facility development

- the director of health services:
 - 1. serves as a liaison with city and county emergency management officials in planning for critical events that might impact the school
 - 2. works with operations closely to promote design that balances aesthetics of a good learning environment with safety and security (such as determining designations for "weather-safe rooms" in schools with a multitude of windows)
 - 3. coordinates the Emergency Operations Plan and security audit requirements from Senate Bill 11
- c. utilize citizens' advisory committees to focus on short and long-term tasks
- the School Health Advisory Council (SHAC) meets at least twice a year, and consists primarily of parents of current DISD students; their role is to make recommendations to the board in the areas of comprehensive school health (attachments C, C1)
- the director and five other nurses serve on campus CLTs
 - d. provide support services and promote health, wellness and safety for students and families
- each day our highly-skilled nurses work to support student success, making good nursing assessments and decisions - quickly returning our students safely to class when possible and sending students home who, for health reasons, should not be at school. In emergent or critical cases when the needs of the student are beyond our resources, she calls 911 to facilitate rapid advanced treatment and transport

to the hospital, where she stays with the student until a parent or guardian arrives. Last year our nurses handled 61 emergent issues requiring ambulance calls.

- Our 30 school RNs had over 141,000* documented health room visits/contacts in the 07-08 school year. Out of those visits, the vast majority (attachment D) were discharged safely back to the classroom setting, based on the nurse's assessment of the student's condition, communication with the parents, teachers, and campus administrators, and, with older students, their own input. Their skills in making accurate assessments and appropriate referrals contributed greatly to better attendance and optimal school performance for our students; we strive to protect the integrity of instructional time.

 *(includes health room visits for illness/injury, screenings, and medication administration)
- A study published by the Commonwealth Fund and released in spring of 2008 focused on measuring states' performance in children's health care access, quality, costs, equity and the potential to lead healthy lives. Overall, Texas ranked 46th out of 50 states, plus the District of Columbia. It scored 50th in children's access to health care, 44th on equity and 42nd in quality of children's health care. Because of this (very poor) ranking in our state, all too often the school nurse is the only health care provider our students see. We work hard as advocates for them and their families, linking them up with much-needed resources and finding them a medical home. If our students are to be successful in school (and life), their basic health needs must be met first.
- we coordinated a family fun walk in conjunction with Denton County Medical Alliance who distributed bicycle helmets - 16 in attendance
- school nurses provided over 3200 hours of classroom instruction for students in areas of health and safety
- supported /assisted the PE teachers in the Fitnessgram assessments for all students in grades 3-12

V. Human Resources...In pursuit of excellence, the district will:

 a. develop and expect a consistently high level of, and respect for, professional performance by all staff

- school nurses' performance expectations are based on the "Standards of Performance" from the National Association of School Nurses and are assessed at least annually (or at least twice annually for new employees) by the director of health services with input from the campus administrators
 - c. maintain a diverse workforce with respect to qualifications, expertise, and commitment to excellence
- our nurses have 496 combined years of nursing experience in such diverse and various clinical fields as: pediatrics, critical care, cardiac nursing, normal newborn and NICU, care flight, university health, office nursing (ENT and pediatrics), OB/GYN, emergency care, recovery room, hospice, home health, medical/surgical care, operating room, orthopedics, occupational health, neurosurgery nursing, geriatrics, public health, nursing administration, with specialties in lactation education, diabetes education, childbirth education, endocrine, asthma, ostomy care, cystic fibrosis, pharmacy, sports medicine, psychiatrics, QA and Infection Control. They are all CPR, AED, and First Aid instructors, and two are also certified teachers.
- health services has one Hispanic RN, two others who are also fluent in Spanish, and three African-American RNs
- maintain a registered nurse substitute pool of 32 (recruit, orient, evaluate) to manage the health room in the absence of the full-time nurse

e. promote health and wellness in the workforce

- school nurses provided assessment and care for 16,008 documented employee visits to the health rooms
 - we upgraded the wellness center facility with three donated machines (treadmill, elliptical, and bicycle), mirrors on the wall facing the workout surface, added a wellness library and self-assessment area
 - district wellness committee (44 members) met each month to discuss/implement wellness activities, discuss communication and motivation strategies, and share building happenings, which were then posted on the wellness website
 - some of the wellness activities for 07-08 school year included:
 - 1. WOW Working on Wellness program

- 2. Just MOVE (Make One Vital Effort)
- 3. Spread the WARMTH (We Are Role Models for Teaching Health)
- 4. HealthStart 2008 employee wellness day 193 attendees and 28 vendors/health assessment booths
- 5. Flu Shots administered 1,807 flu shots to employees and their adult family members
- 6. Activities in the Wellness Center yoga, nia, step, balance ball, resistance training had 102 employees registered in this program
- 7. Principal Wellness Assessments over 60% employee participation
- 8. Fun Walks sixteen in attendance
- 9. Employee mammograms with mobile unit from Baylor 120 participants

VI. Growth & Change...In pursuit of excellence, the district will:

- a. review and adjust policies and procedures effectively to address the challenges of rapid growth and changing demographic characteristics while maintaining and enhancing our strong sense of community
- director prepared/introduced two policy changes last year (anaphylaxis and TB testing for certain staff)
- continue to implement district wellness policy FFA (local)
- coordinated and help conduct security audits on all campuses, prepared reports,
 communicated needed changes with building administrators
 - b. create and continuously modify strategies to mitigate increasing stresses on our children, our schools, and our community
- the school nurses collaborate with the school counselors to identify areas of stress among students, faculty and staff, and provide activities and resources to help minimize the effects of stress on those groups
- all of our nurses attended a critical incident stress management workshop with the counselors, and the director is certified as a critical incident stress debriefer to help in school, district, or community-wide events
 - c. be environmentally responsible and aggressively pursue energy efficiency and conservation principles in building design, transportation alternatives, and operating procedures
- director works closely with district operations in building revision and design from the safety and security standpoint to meet the objectives outlined in the district emergency operations plan, serves on the "green team," and the IAQ response team.

"Sister"...part of a family, cheering each other on "HOOD"... Help with Orientation, On-call, and Disasters!

Purposes: to broaden the "sister school" concept into areas of small sectors for mentoring, and to provide emergency or "on-call" nursing resources in proximity to each school

Each sisterhood has "big sisters," seasoned DISD nurses who will assume the role of checking in with our newer nurses ("newbies"), be the "first source question-answerer," and provide support when needed...like on a daily basis!

Each nurse will:

- Familiarize herself with sisters
- Visit sister campuses to find parking, locate the health room, meet office staff and determine where critical equipment is kept (meds, assessment equipment, AED, evacuation bag, chocolate ©)
- Give each of her school office staff a copy of the in-house distribution roster, highlighting her sister nurses and the director's beeper number

Big sisters will:

- Check in weekly with newbies to determine progress
- Set up screening calendars and schedule who will help when and where
- Provide evaluative information to director on newbies
- Help with CPR and first aid class monitoring
- Demonstrate classroom teaching (age appropriate) for newbies and monitor their first classes

Secondary Nurse's Recommendation

Cindy Fitzgerald, R.N. and Pat Jolly, R.N. presented recommendations regarding abstinence curriculum and manangement of parenting teens for Denton ISD. The goal is to break the cycle of repeat behaviors, teach healthy relationships, and teach respect for yourself and others.

<u>FitnessGram update</u>

98% of 3rd-12th grade students have been tested and data entered. Data is available to parents upon request. Cooper is funding, offering software and technical support. The Cooper website has great information regarding food, test scores, and academic standings.

A question was asked, "if the letters are not going home, how will the parents know the results?" Kim Crane said teachers need to make the judgment call and if a student is in the unhealthy fit zone they should make the parent aware. The "norm" is overweight.

Implementing: Schools have some but not all the influence on children's health. Strickland offers one advisory class a month covering health issues.

Senate Bill 11- safety and security audits
