We recommend the Board of Education approval of Trade Contractor Contracts (\$1,768,240), General Conditions cost (\$88,412) and Contingency Cost (\$176,824) totaling \$(2,033,476).

Bids were received August 28, 2024, for the above referenced projects. We have conducted post-bid review meetings with the recommended bidders. We have received each Contractor's assurance that they are committed to meeting the requirements of the contract documents.

In addition to the direct Trade Contractor costs, General Condition costs will be incurred. General Condition costs include items such as building permits, security and safety requirements, temporary utilities etc. Cost from this fund will not be committed without prior approval of the District Administration for each item.
