Regular Meeting
SCHOOL BOARD
FEBRUARY 18, 2025

Chair Yang called the meeting to order at 6:01 PM with the following present: Chair Yang, Clerk Livingston, Treasurer Martens, Directors Nitardy, Swor and Yener, and Superintendent Tucci Osorio. Arrived at 6:49 PM: Vice-Chair C. Anderson

The meeting opened with the Pledge of Allegiance.

Livingston moved and Martens seconded the following motion, which carried on a 6 – 0 vote:

Nitardy moved and Martens seconded the following resolution, which carried on a 6 – 0 vote:

BE IT RESOLVED by the School Board of Independent School District No. 622 that the following Consent Agenda Items, IV.A. through IV.F., be approved as written, and a copy of the agenda items is attached to the minutes.

WHEREAS, the school board or district affords the AIPAC the necessary information and the opportunity to effectively express their views concerning all aspects of American Indian education and the educational needs of the American Indian children enrolled in the school(s) and program(s); and,

WHEREAS, the AIPAC is directly involved with and advises the school board and district staff on Indian Education program planning; and,

WHEREAS, the AIPAC develops and submits recommendations to the school board and district staff pertaining to the needs of American Indian students.

THEREFORE BE IT RESOLVED, that the AIPAC concurs that the school board and district are compliant with Minnesota Statutes, section 1240.78, and that the school board and district are meeting the needs of American Indian students.

Yener moved and Martens seconded the following resolution, which carried on a 6 – 0 vote:
