

BIOGRAPHICAL SKETCH - EXECUTIVE BOARD CANDIDATE - SUBREGION I

DIRECTOR OF SPECIAL EDUCATION

Carla Cumblad serves as the Executive Director of Mid-Valley Special Education Cooperative. Prior to this appointment, Dr. Cumblad coordinated the implementation of Response to Intervention (RtI) in Elgin U-46, the second largest district in Illinois. Formerly, she was the Assistant Superintendent for Special Services in Arlington Heights D25 where she oversaw all programming for special education and RtI implementation. She was a Coordinator for Northwest Suburban Special Education Association (NSSEO) where she was also assigned to Arlington Heights. Dr. Cumblad was one of the founding members of the Illinois Flexible Service Delivery Consortium and has served in a leadership role for the Illinois ASPIRE RtI grants. She also has had experiences working on U.S. Department of Education federal projects, consulting, and teaching coursework at Northern Illinois University.

MEMBER-AT-LARGE

Kathy Countryman, Assistant Superintendent of Sycamore CUSD #427, received her undergraduate and Master's Degrees in Education from the University of Iowa. She also holds a Superintendent Endorsement from Western Illinois University. Kathy spent 8 years teaching in Iowa prior to moving to Illinois. Her administrative career began in Indian Prairie #204 in Naperville as Assistant Principal. Her tenure with Sycamore Schools began the fall of 2000, as the principal of Southeast Elementary School. In 2004, Kathy was appointed Assistant Superintendent, a role she will hold until July 1, 2012 when she will become the Superintendent.
