2. National Board Members Day – November 15, 2022

Dr. Mutchler presented Board members with certificates from the Illinois Association of School Boards (IASB) for National Board Members Day on November 15, 2022. He also presented Board President Mike McCormick with a certificate from IASB for being honored as an established board member.

English Learners Presentation - Shonette Sims Shonette Sims shared with the Board information on the ELL program. Eligibility for students is determined by families completing a Home Language Survey upon enrollment indicating whether a language other than English is spoken in the home or that a language other than English is spoken by the student. Next, the student would be given a language screener to determine if they are eligible for EL services. If a student is eligible, there are two placement options. There is the Transitional Program for Instruction (TPI), and the Transitional Bilingual Education Program (TBE). The district currently has 426 students that speak a language other than English, with 157 students eligible for services. We are currently using two-way translation, instructional resources, and Office 365 as instructional support tools. Students who are eligible for services must take the ACCESS test annually. Once a student is determined English proficient, they no long are required to receive EL services, they are no longer required to take the ACCESS assessment, and are monitored for four years. The district is required to have a Bilingual Parent Advisory Committee that meets four times annually. The program is also required to have a Bilingual Service Plan, a Consolidated District Plan. Bilingual Education Program Delivery Report, EI-EBF Expenditure Reporting, Grant Periodic Reporting, and professional development for staff.

Board comments, questions, concerns: How many families opt to take the program at Harrison Street School? (Many of them.)

- 4. Geneva Early Learning Program Update GELP Staff
 Staff from the Geneva Early Learning Program (GELP) presented to the Board an overview of the pre-school program, which is housed at Fabyan Elementary School. The program has a program coordinator, administrative assistant, six classroom teachers, eleven instructional assistants, two and a half speech-language pathologists, a psychologist, a social worker, an occupational therapist, and a physical therapist. There are twelve sections (6 total classrooms, AM and PM sessions, ten sections of blended learning, two sections of instructional learning, and around 15 students in each classroom. The purpose of this program is to provide a quality education for the youngest learners. The curriculum is play-based teaching and learning. Students are assessed through the Illinois Early Learning and Development Standards, progress updates, and a pilot program call MyIGDI's. The schedule allows for gross motor time, small group, large group, centers, weekly speech group, social work group, and library time.
- 5. State Report Card Summative Designations
- Dr. Andy Barrett shared information on how to better understand summative designations on the 2022 School Report Card. Designations are calculated by weighting eight indicators and then comparing overall calculations of schools from across the state. Elementary and middle schools fall into one designation band, while high schools have a different set of indicators and are evaluated separately. The eight indicators are ELA growth, math growth, ELA proficiency, math proficiency, science, ELPtP, chronic absenteeism, and climate survey. Geneva currently has a 97% graduation rate compared to the state average which is 87.3%. Growth indicators tell us how far a student has progressed from one point in time to another, proficiency indicators tell us how students perform in relation to specific skills, requirements, or standards. Student Growth Percentiles (SGP) are used to compare individual points to a broad population. We traditionally use percentiles to understand where an individual falls in comparison to peers. An SGP at the 50th percentile represents typical growth. With proficiency, we need to understand the challenges of the pandemic, importance of comparison with other data, state-specific benchmarks, inconsistency between elementary/middle school and high school designation bands and finding areas of growth. Chronic absenteeism is defined as a student who misses ten percent (18 days) of school days within an academic year with or without a valid excuse. There are four possible designation bands, which are exemplary, commendable, targeted support, and comprehensive support. All Geneva schools received either an exemplary or commendable designation. This tells us that Geneva students are demonstrating solid growth. We will continue to use a wide variety of tools and data to help us to continue to grow and support students.

Board comments, questions, concerns: Do you think we will be using IAR versus MAP testing? (It is

something we are talking about.) Have we thought about how we might communicate this information to parents? (This is something we are struggling with. We are hoping that tonight's presentation would be one way to inform parents.) Is proficiency with math and language significantly different? (We do not know.) Is it actionable? (Absolutely.) Do we understand why 30% of our high school students are chronically absent? (This is something we need to be looking at.) Can we see what other schools are doing? (No.) If we look at each individual student and not at their score, but instead at how much they grew, isn't that looking at them and saying maybe we didn't allow the student to grow enough? (The risk would be if we make the program easier, the student could show more growth that way, rather than learning more.) As a high performing district, we don't have a lot of room to grow. Does our absenteeism include the state mental health days? (Yes.)

6. Proposed 2022 Tentative Tax Year Levy – Todd Latham

Todd Latham presented the proposed tentative 2022 tax year levy, which consists of the Equalized Assessed Valuation (EAV), new property/construction, Property Tax Extension Limitation Law (PTELL), Consumer Price Index, tax rates, and total extension. The EAV is estimated at 5.46%, new property/construction is estimated at \$14,311,477, and the PTELL cap for 2021 is 5.00%. Funds subject to PTELL are education, special education, operations & maintenance, transportation, social security, IMRP, and fire prevention & safety. The limiting rate is estimated at 5.859, which is the calculated total allowable tax rate used to calculate the total tax extension. Using the levy assumptions, it is estimated that the 2022 tax year levy will be 3.24%. The levy will be voted on at the December board meeting.
