

## MEETING DATE: April 19, 2022

AGENDA ITEM: Consider Approval of Technology Purchases for 2022-2023 School Year

**PRESENTER:** Brooks Moore, Director of Technology and Earl Husfeld, Chief Financial Officer

### **BACKGROUND INFORMATION:**

- Per Board Policy CH (Local), any single, budgeted purchase of goods or services that costs \$50,000 or more, regardless of whether the goods or services are competitively purchased, shall require Board approval before a transaction may take place.
- As we shared with you during the March 21, 2022 board meeting, the 2015 Bond Program included technology upgrades throughout the District. Several of these items are beyond their lifecycle and need to be replaced.
  - CTE Student Computer Labs Computer labs need to be upgraded at Aledo Middle School, Daniel Ninth Grade, and Aledo High School.
  - Promethean Board Computers Each Promethean board has a Windows computer directly attached to the display for teachers to be able to use for instruction, independent of their district issued laptop.
  - Support Staff Computers Support staff computers need to be replaced throughout the District. These computers are used primarily in campus front offices, Auxiliary Services, Administration, etc.
  - Uninterrupted Power Supply (UPS) This hardware is used to ensure network connectivity stays active in the event of a brief power outage. Each network router and switch need to be connected to a UPS throughout the District.
- Computers also need to be purchased for the additional staff positions being added to the District for the 2022-2023 school year.

### FISCAL INFORMATION:

\$9,716.56 of the cost of these items will be paid from 2019 Bond Funds allocated to McAnally Middle School and the remaining \$623,110.30 will be paid from 2015 Bond Funds.
